

## PRESS NOTE

### LB NAGAR POLICE NABBED THE NOTORIOUS GANG WHO COMMITTED THEFT OF NET CASH FROM THE SBI ATM OF MANSOORABAD AND RECOVERD A NET CASH OF Rs8,00,000/- AND ONE AUTO.ALL W/RS.12,00,000/-.

On 03.10.2019, sleuths of L.B Nagar Police station nabbed four HB night offenders, while moving in suspicious circumstances in the un-registered auto in the limits of PS LB Nagar and recovered a net cash of Rs8,00,000/- and said un-registered auto from the possession of the accused A1. All W/Rs. 12,00,000/-.

#### Brief facts of the case :

The complainant is working as a channel Manager at EPS (Electronic Payment & Services an Outsourcing Company based at Mumbai) and taking care of ATMs at Dilsukhnagar, L B Nagar, Vanasthalipuram & Meerpet regions. On 01-10-2019 at about 1100 hours the Cash custodian (CMS) replenished a cash of Rs 10,00,000 in SBI ATM of Mansoorabad. On 02-10-2019 at about 0700 hrs in the morning time the complainant visited at Mansoorabad SBI ATM, Near Dhanalakshmi Kiran general store in regular course and noticed ATM chest walls broken with a gas cutter and found some of the cash in burnt condition and remaining cash of Rs. 15,03,000/- was stolen by some unknown offenders.

#### DETAILS OF THE ACCUSED:

A-1 Saber Khan S/o Ruddar Khan, age: 39 yrs, Occ: Auto driver, R/o Shaheennagar, Vade mustaffa hills, Shaheennagar, Hyderabad. C/o H.No. 8-12-418/D69 Hafeez baba nagar, Ward -18, Circle-2 of Hyd. N/o Nayagara (V), Nayinagla(Tq), Haryana State.

A-2 Arshad Khan S/o Umar, age: 20 Occ: Labor R/o H.No. 74 Shikapur Village Tauru TQ Mewat, NuhDist, Haryana State. PIN.122105.

A-3 Ajrudeen S/o FatheMohdmmad age: 25 Occ: Helper/ painting R/o H.No. 171 Sabras Village Tauru TQ Mewat, NuhDist, Haryana State. PIN.122105.

A-4 Talim S/o Ibrahim age: 20 Occ: Helper R/o H.No. 29 Guddhi Village Tauru TQ Mewat, NuhDist, Haryana State. PIN.122105.

A-5 Sajeed @ zahid S/o Shakir age: 25 yrs R/o Shikarpur, Thandu (PS), NuhDist, Haryana (Absconding)

The accused A1 to A4 were arrested on 03-10-2019 at 0900 hours and being produced before the Hon'ble court.

The accused A1 is a native of Harayana State came to Hyderabad about (17) years ago in search of a job and settled in Hafeezbabanagar, Hyderabad by plying an auto. The other accused A2 to A5 also belonged to Harayana State. The accused A1 is well known to A3 Ajrudeen and A5 Sajeed. The accused A1 previously involved in a cheating case at ATM Centre of Kachiguda PS limits vide Cr.No. 292/2017 U/s 420 IPC of PS Kachiguda wherein he had drawn an amount of Rs. 20,000/- from the ATM by cheating an old person and was arrested and facing trial.

The accused A1 hatched a plan to commit theft of cash from the ATMs by using gas cutters. Accordingly he made a call to the accused A2 to A5 of Harayana State about (18) days ago and invited them to Hyderabad for committing ATM offences. According to their plan, the accused A2 to A5 arrived at Nampally Railway station by Telangana express on 30-09-2019 in the evening hours and halted at A1's residence. On 01-10-2019 the accused A1 and A5 went to Gogineni Enterprises of Ranigunj and purchased a gas cutter for Rs. 9,300/-. According to their plan on the same night i.e., on the intervening night of 01/02-10-2019 at about 0230 hours, the accused A1 came to Mansoorabad along with his un-registered auto with A2 to A5 and gained entry in to the SBI ATM, Mansoorabad and broke the ATM with the gas cutter and committed theft of net cash of Rs. 12,07,000/- from the said ATM and fled away with the stolen booty by leaving the gas cutter at the ATM Centre. The ATM was partially burnt and some of the cash around Rs. 7000/- was also burnt. The remaining cash of Rs. 2,96,000/- were found in the ATM Machine and it was seized at the scene of crime.

On 03-10-2019 at about 0900 hours, while conducting vehicle checking the above accused A1 to A4 were arrested while travelling in the un-registered auto at Sagar ring road, LB Nagar and recovered a net cash of Rs. 8,00,000/- and un-registered auto of all worth Rs. 12,00,000/-. The remaining cash of around of 4,00,000/- was with A5 (absconding).

The arrest was made under the supervision of Sri. Mahesh Bhagwat, I.P.S., Commissioner of Police, Rachakonda and under the guidance of Sri Sunpreet Singh IPS, DCPLB Nagar Zone and under the directions of Sri K. Pruthvidhar Rao, Asst. Commissioner of Police, L.B Nagar Division, by Sri V. Ashok Reddy, Inspector of Police and Sri D.Krishna Mohan, Detective-Inspector of Police, Sri H. Raghavender, Detective Sub-Inspector of Police, PC's- Sri Raj kumar- PC 5817, Sri K. Gopal Rathod- PC 3803, Sri Rajender- PC 6022, Sri Balakishan- PC 3266 of L.B Nagar PS, Sri Kirankumar- PC 5733, Sri Srinivas- ARPC 6892. All are suitably rewarded.
