JOINT OPERATION TEAM CONSISTING OF SOT LB NAGAR ZONE TEAM, CCS LB NAGAR TEAM, AND HAYATHNAGAR TEAM OF RACHAKONDA COMMISSIONERATE BUSTED A NOTORIOUS INTERSTATE DACOITY GANG CONSISTS OF SEVEN MEMBERS FROM HIMACHAL PRADESH NABBED AND DETECTED (8) CASES OF TELANGANA & (6) CASES OF OTHER STATES - RECOVERED 150 GRAMS OF GOLD ORNAMENTS, 400 GRAMS SILVER, 4 MOBILE PHONES, NET CASH RS.3,000/- AND TWO KNIFES. ALL WORTH RS. 6.55 LAKHS (SIX LAKHS AND FIFTY FIVE THOUSAND) FROM THEIR POSSESSION.

Series of offences committed by “**NOTORIOUS DACOITY GANG**” in the limits of Rachakonda Commissionerate in the month of October, November-2019. The Commissioner of police Rachakonda **formed a Special team with Sri. T.Ravi Kumar, Inspector SOT LB Nagar, Sri. A. Ramulu, Inspector CCS LB Nagar, Sri. B. Nagarjuna DI Hayathnagar PS to apprehend the DACOITY GANG.** By using high end technology and Human intelligence information system with high professionalism. Teams worked for Two months and visited six states i.e. Maharashtra, Madya Pradesh, Uttar Pradesh, Delhi, Gujarat and Himachal Pradesh, after laborious technical and physical work, finally our teams identified the **movements** of the offender’s in Akola of Maharashtra state and Shimla of Himachal Pradesh. Immediately the team are mounted physical and technical surveillance on the movements of offenders, as they were moving in very remote places, after mounting of Human and Technical surveillance teams were back to Hyderabad.

Today all our efforts are fruitfully resulted and received authentic information that the offenders once again planned to commit the offences in the limits of Hayathnagar police station, which is very conducive with bushes, open areas and dark spots and easy to escape through Outer Ring Road (ORR). Immediately SOT Team under the leadership of Inspector Sri. **T. Ravi Kumar** rushed to spot, mean time CCS team lead by, Sri. **A. Ramulu, Insp** and Hayathnagar team lead by **Insp Sri. Satish, Hayathnagar** and Sri. **B. Nagarjuna** DI Hayathnagar were also rushed to the spot and surrounded the area from 3 corners with their teams and apprehended the Notorious Dacoity Gang consists of (06) members on the spot. On questioning them, they revealed that one of Gang member is kept at LB Nagar Metro Station with booty. Immediately team went to Metro station and apprehended one Gang member by name **MD. Sajeed with a shoulder bag containing with Gold ornaments.** after thorough interrogation they have confessed their involvement in the following offences of Rachakonda Commissionerate and Nizamabad District. They also committed offences in Rajasthan, Maharashtra and Gujarat States. **After this offence, they planned to go to Delhi to dispose the Booty.**

MODUS OPERANDI:

The Gang member Families are **NOMADIC belongs to Muslim Ccommunity.** Their Grandparents are **migrated from Bangladesh** to West Bengal decades back. they used to move state to state and they always choose outskirts of the cities and stays in Tents at isolated places of Cities. They used to sale Blankets and toys at road side. from last two years they stayed in Rajasthan, Gujarat, Madya Pradesh, Himachal Pradesh, Maharashtra presently staying in Khadki area Akola town of Maharashtra.

This Gang (**GHUMAN GANG**) (In Hindi **NOMADIC** called as **GHUMANTOO**) was formed 3 years back and moving State to State in trains. Initially they used to select a city and reach the city by train and choose outskirts isolated area, visit that area and conduct the RECCEE and identify the Isolated colonies where semi forest area exists with bushes. then they go there and stay in the bushes up to late night hours. after late midnight They attack on houses and forcibly enter the house by break opening the doors with the boulders and commit the offences. They also commit the offences by breaking the locks.

They used to remove their pants and shirts and keep the same in shoulder bag, because if they move with pant and shirt, there is chance of tear the cloths in bushes, if the cloths are damaged, people may

suspect them. so they used to remove the pants and shirts. by seeing their appearance people rumoured them as CHEDDI GANG. (With this rumours entire investigation was side tracked and delayed in identifying the Gang).

For the first time this gang visited Hyderabad in the month of January 2019 and stayed in Nampally Railway Station for 3 days. first day they recceed Uppal area, Chaitanyapuri area, LB Nagar area, Padmaraonagar area (Near to Secunderabad Railway Station) and Chandanagar area (Colonies near to Railway Station). They committed the offence in Chaitanyapuri area which is very near to Moosi River, in which they entered into a locked plot in a 1st floor but no property last. in this case watchmen of the building was injured.

After few days they again came to Hyderabad and committed offences in Chaitanyapuri and LB Nagar area.

Again Gang came to Hayathnagar in the month of Oct 2019 and committed two offences in Kuntloor area and escaped. Next day they went to Vijayawada and visited Durgamatha Temple, after Darshan they tried to dispose the booty to **SOONARS** but in vain because of their Identity problem, mean while they also recce nearby colonies. (this has to be verified after taking them into police custody) and they went to Akola via Hyderabad. After few days they went to Nizamabad town by train from Akola and committed the offence and went back to Akola. they are not able to dispose the booty in Akola and other Places of Maharastra with fear.

On 20.11.2019 again they came to Kuntloor of Hayathnagar area and stayed near hotels on Vijayawada Highway, after 11pm they went to Kanaka Durga Nagar Colony via Pasumalula Road and stayed in nearby bushes for 1 Hrs and entered the colony and committed 2 offences in Kanaka Durga Nagar Colony.

In a similar manner, this Gang committed (6) cases in different states viz., Rajasthan, Maharashtra, Madya Pradesh & Gujarat States and same is being verified.

The above arrests were made under the Direct supervision of **Sri. Mahesh M. Bhagwat, IPS.**, Commissioner of Police, Rachakonda Commissionerate, Sri. G. Sudheer Babu IPS., Addl. Commissioner of Police Rachakonda Commissionerate, Sri. Sunpreet Sing IPS., DCP, LB Nagar Zone, Sri. P. Yadagiri, DCP Crimes, Sri. D. Srinivas, Addl. DCP, Crimes, LB Nagar Zone, Sri. J. Surender Reddy, Addl. DCP. SOT, Sri S. Jayram, ACP, Vanasthalipuram, T. Ravi Kumar, Inspector, SOT LB Nagar Zone, A. Ramulu, Inspr, CCS LB Nagar, Sri. Satish, Insp Hayathnagar & B. Nagarjuna, DI, Hayath Nagar and Staff of CCS LB Nagar Unit, SOT LB Nagar Team and Crime Staff of Hayath Nagar PS, Rachakonda. **In this case Inspector RAVI KUMAR, SOT played a key role and designed for operation.**
