**ORDER:**

In continuation of the of the orders issued in the reference 1st and 2nd read above, the Government in exercise of powers conferred under section 2 of the Epidemic Diseases Act, 1897 read with all enabling provisions of the Disaster Management Act 2005, having notified lockdown in the entire State of Telangana and also having directed that no movement of any persons shall be permitted for any purpose other than accessing emergency medical care during the period from 7.00 PM every evening to 6.00 AM on the following day, hereby direct that the personnel of following Departments/Offices of the State Government shall be permitted to move as they have to attend duties;

- i) General Administration Department of the Secretariat, Hyderabad;
- ii) All the Staff of the Secretariat and Heads of Department in the twin Cities in the jurisdiction of Hyderabad / Cyberabad / Rachakonda Police Commissionerate; as per the roster drawn by the Departments concerned
- iii) O/o District Collectorate; Divisional offices; Mandal Offices
- iv) Police
- v) Health Medical & Family Welfare Department
- vi) Urban Local Bodies/Panchayat Raj institutions
- vii) Fire Department
- viii) Excise, Commercial Tax, Transport, Stamps and Registration Department
- ix) Energy Department (TRANSCO, GENCO)
- x) HMWSSB
- xi) Agriculture, Horticulture, Animal Husbandry, Fisheries and Marketing Department
- xii) Consumer Affairs, Food & Civil Supplies Department
- xiii) Regulatory departments like Pollution Control Board, Legal Metrology, Drug Control Administration.
- xiv) The Singareni Collieries Company Limited
- xv) All Central Government departments related to the above.
- xvi) All the staff drafted for control activities of COVID-19, by the above office(s)
- xvii) National Informatics Centre

2. The DGP/Commissioners of Police/Superintendents of Police in the State shall allow the employees/officers of the above Departments / Offices, by viewing their ID Cards issued by the respective departments, with immediate effect.
