THE COMMISSIONER OF POLICE, RACHAKONDA DETAINS (2) NOTORIOUS HOUSE BURGLARIES OFFENDERS VIZ., 1) NENAVATH VINOD KUMAR @ AKHILESH KUMARDONGRI MANISH @ SONU @ MANIK UNDER P.D. ACT ON 01-07-2017.

In ongoing drive against offenders to create safe and security to the public for safe guard of their jewelry, Automobiles in Rachakonda Police Commissionerate the Commissioner of Police has detained notorious Property offenders who have committed as many as (09) House burglaries and Automobile thefts in the limits of Ghatkesar, Medipally, Chaithanyapuri, Saroornagar and Meerpet of Rachakonda Police Commissionerate and SR Nagar of Hyderabad City repeatedly. They have created panic and terror in the minds of public.

The people in Rachakonda are dare not to go out duly locking their houses or parking their motor vehicles alone and were under tremendous fear to attend basic requirements such as going out of home to attend their jobs duly locking their houses to attend marriages/functions etc,... Further, their acts are creating feeling of insecurity to the gold jewelry and motor vehicles of the public. Unless they are detained by an order of detention for a considerable period, their activities cannot be curbed.

The A-1 Nenavath Vinod Kumar was earlier arrested by the Police and invoked under PD Act by the Hyderabad City Police and even though he did not change his attitude and continued to commit property offences along his associates soon after release from jail. The A-2 Dongri Mahesh was also earlier arrested by Kachiguda Police and served in jail.

The Ghatkesar Police arrested the both the accused and recovered 10.4 tolas of Gold Jewelry, 8 tolas of Silver ornaments and (03) Motor Cycles total W/Rs 5,11,800/-

Hence, Preventive Detention orders are invoked against the following offenders by the Commissioner of Police, Rachakonda Sri Mahesh M.Bhagwat, I.P.S., Commissioner of Police, Rachakonda, as a part of preservation of peace and maintaining public order in Rachakonda and to check the menace of House burglars in Rachakonda Commissionerate on 01-07-2017 and detained them in Central Prison, Cherlapally.
