

## PRESS NOTE.

Rachakonda Police have arrested one Person by name M.V. Shiva Reddy of Nandhini Seeds in relation with unauthorized/illegal processing, packing, distribution and selling of Spurious Seeds and cheating the farmers of Telangana, Andhra Pradesh.

### Brief Facts:-

On 05.07.2017 on receipt of credible information with regard to unauthorized/illegal processing, packing, distribution and selling of Spurious Seeds and selling unauthorized in a Godown in Sy. No; 140 of Munuganoor village, Hayathnagar, Special Team consisting with Sri J. Narender Goud, Inspector of Police Hayath Nagar, Sri Venkateswarlu, Inspector of Police SOT L.B.Nagar along with Staff and Agricultural Department Officials raided at the said premises and found bulk of seed packets and bags.

- 1) Bhendi of Varashitha, 810 packets worth of Rs; 6.48 lakhs,
- 2) Arka Anamika Bhendi of 150 packets worth of Rs; 1.2 lakhs,
- 3) Cotton seeds Mahanandi 88  
KSCH-232 BGII 1300 packets worth of Rs; 10.40 lakhs,
- 4) Cowpea 150 packets worth of Rs; 45,000/-
- 5) Beans-100 Packets, (500 grams x 100= 50 Kgs), W/rs: 7,000/-
- 6) Bulk Cluster Beans 9 bags (50 kg x 9= 450 Kgs) W/rs: 54,000/-
- 7) Bulk Ridge Guard 3 bags (25 kg x 3= 75 Kgs) W/rs: 90,000/-
- 8) Bulk Cucumber 2 bags (50 kg x 2= 100 Kgs) W/rs: 40,000/-
- 9) Bulk Bitter Guard 10 bags (50 kg x 10= 500 Kgs) W/rs: 6, 00,000/-
- 10) Bulk Remnant Maize 10 bags (50 kg x 10= 500 Kgs) W/rs: 22,500/-
- 11) Bulk Bottle Guard 1 bag (20 kg x 1= 20 Kgs) W/rs: 12,000/-
- 12) Bulk Ridge Guard 3 bags (25 kg x 3= 75 Kgs) W/rs: 90,000/-
- 13) Mixing machine (used for mix the seeds with remnant seeds)
- 14) Pressing and packing machines-3

Samples were drawn to send the Lab for examination to know the genuinity of seeds. The accused M. V. Shiva Reddy started the seed business in the year 2010 in the name and styled as Nandhini Agro Bio-Tech initially at AG Colony, Nalanda Nagar, Hyderguda, Atthapur. Later shifted to flat no; 34, SKD Nagar, BN Reddy Nagar, Vanasthalipuram, RR dist. The accused thought of gaining huge profits by doing business in illegal manner. He accused used to collect the returned, remnant, expiry dated seeds and illegally doing reprocessing, packing and selling to dealers and farmers in the name of good quality seeds and cheating them. Six months back he has taken a godown in Sy. No; 140 of Munuganoor village on rent basis and started this illegal business without having any permissions from the concerned. The accused Shiva Reddy previously involved in Cr. No; 350/2017, U/s 420 IPC, DT: 11.06.2017 of PS, RGIA Airport PS of Cyberabad Commissionerate also for similar offence. All the seized material worth Rs; 27, 86,500/-.
