5 Accused arrested in murder case of Gunti Rajesh. Old rivalry is reason

The accused persons namely :-

A-1 M. Shyam Sunder Reddy S/o Rami Reddy, aged about 48 years, Occ: Business, r/o Flat No. 106, Pramukha Plaza, road No. 4, Green Hills colony, Kothapet now resident of H. No. 17-1-386/9/3, S.N. Reddy Nagar, Saidabad, Hyd.

A-2 Shaik Mohd Kaleemuddin S/o Yaseenuddin age:46 yrs Occ; Real estate Business R/o Villa No.74, dream valley, opp: Piller no.306, Shivaram pally, Rajendra Nagar, Ranga Reddy District.

A-3 Kunchepu Ramana S/o Veerappa age:36 yrs Caste:Vaddara R/o Narappagari Pally, Odisi Mandal, Ananthapuram Dist. (**previously he is involved in Cr. No.339/2012 U/s 302,201 IPC of PS Shadnagar**)

A-4 Pogari Dayakaer S/o Dyvadeenam age:27 yrs Caste: Baliya Occl Driver R/o Mella Chervu village, Piler Mandal, Chittur Dist, AP.

A-5 Chinth Shyamsunder Rao s/o Ch. Peddaiah, aged 32 years, Occ: Civil engineer , caste: SC r/o H. No.3-4-86, new RTC colony road, LB Nagar, RR district N/oNarketpally village and Mandal, Nalgonda dist.

On 02.03.2015 in afternoon hours accused A-1 to A4 arrested at ORR Service Road, Near Wonderala Holiday Park, Raviarla., on interrogation they confessed to have Murdered Gunti Rajesh @ Raju s/o Late Jangaiah, aged about 35 Yrs., Occ; Business, Caste: SC-Madiga. A-5 arrested from his residence, LB Nagar on 03.03.2017 morning. On interrogation he confessed on assisting A1 to A- 4 by giving the information on deceased movements.

On 27-2-2015 the deceased Gunti Rajesh has kidnaped A-1's Daughter Anusha and forcibly taken away and had exploited her sexually by blackmailing her for which a case in Crime No.121/2015 u/s U/s 417, 363, 384, 376, 495, 496, 313 IPC was registered and he was remanded in which he is facing the court proceedings. While the matter stood thus on 18-3-2015 the accused A-1's daughter had committed suicide on the night of 17/18-3-2015 by jumping into the Nagarjuna sagar, which is subject matter in Cr. No.33/2015 U/s 174 Cr. PC of PS Nagarjuna sagar, Guntur dist. Due to which A1 decided to eliminate him by keeping the grudge and since then he was waiting for an opportunity.

Matter stood 20 days back accused A1 has contacted his friend A2 and requested to help to take his revenge. A2 agreed for it and he also arranged A3 and A4 to assist them to murder the deceased. A1 also took the help of A5 who is a friend of deceased to know the movements of the deceased.

Since then they were waiting for an opportunity to eliminate him by watching his movements. Finally they have decided to eliminate him at any cost on 27.02.2017 as it is the day on which A1's daughter was kidnapped by the deceased two years back . According their plan on 27.02.2017 on intimation given by A5 about the deceased leaving from his house, A1 to A4 have followed him from Sagar ring road and murdered the deceased at about 2230 hours by attacking with knives. They have stabbed the deceased on his neck, chest and stomach. As a result the deceased Rajesh received severe injuries on his body and died on the spot. After the offence accused fled away from the spot.

In this case seized 1) one car bearing No:AP9AU3004 (skoda), 2) 3 knives (one among them was seized from scene of offence), 3) 1 iron rod, 4) One Bajaj Discover Bearing No:AP24BB7471 5) 5 cell phones from the above said accused persons which are used during commission of offence
