### **Notorious cheater foisting false cases on couple nabbed**

**Accused : B.Prakash Reddy S/o Sri B.Inna Reddy R/o Flat No.608, White House apartments, Road no.13, Banjara Hills, Hyd**

The sleuths of SOT Rachakonda apprehended one B.Prakash Reddy who was foisting false cases at many police stations against one couple A.Anil Kumar Reddy and his wife A.Showrilu R/o Flat No.GF-8, Venkat Sai Villa, Street No.5, M.J.Colony, Moulali alleging that there are money disputes between them and some civil cases are pending in various courts and that the couple are giving him threatening messages from their cellphones asking him to withdraw the cases otherwise face dire consequences.

In this regard Sri A.Anil Reddy lodged complaint at Malkajgiri P.S on 08-04-17 against B.Prakash Reddy in which he stated that there are financial disputes between him and Prakash Reddy who is the distant relative of his wife Showrilu and Prakash Reddy has procured many SIM cards using the photographs and ID proofs of his and his wife and he himself is sending threatening messages to his phone using those SIM cards and foisting false cases against them alleging that they are threatening him. On the complaint of Anil Reddy a case in Cr.No.253/17 U/s 468, 471, 474, 420, 182, 203 IPC is registered at Malkajgiri P.S against Prakash Reddy. The different cases foisted by Prakash Reddy against Anil Reddy and his wife are:

**Chaitanyapuri P.S:** In December 2015 a case is registered in Chaitanyapuri P.S vide Cr.No.217/15 U/s 387, 506, 507 IPC in which he alleged that Anil Reddy sent him a threatening message from his cell no.8978068793 to Prakash Reddy cell no.9395599434. The cell no.8978068793 does not belong to Anil Reddy, but Prakash Reddy took the above cell connection by submitting the ID proof and photograph of his wife Smt Showrilu by forging the documents.

**Malkajgiri P.S:** In the same manner on 04-05-16 he got another case registered in Malkajgiri P.S vide Cr.No.355/16 U/s 387, 506, 507 IPC in which he alleged that they sent him a threatening message from cell no.8978068793 to his cell no.9395599434.

**Neredmet P.S:** In the same manner on 01-05-16 he got another case registered in Neredmet P.S vide Cr.No.307/16 U/s 387, 506, 507 IPC in which he alleged that they sent him a threatening message from their cell no.8978068793 to his cell no.9395599434.

**Gachibowli P.S:** In the same manner in November 2016 he got another case registered in Gachibowli P.S vide Cr.No.457/16 U/s 387, 506, 507 IPC in

which he alleged that they sent him a threatening message from their cell no.8978068793 to his cell no.97799633797.

**Maredmilli P.S, East Godavari :** In the months of January 2017 Anil and Showrilu received call from Maredmilli P.S, East Godavari district asking them to come to P.S as one Ganja case is registered against them vide Cr.No.13/17 under NDPS Act. When they went and spoke to the S.I they were told that one Maruthi Car no.AP 36E 9594 was found abandoned in their P.S limits and Ganja was found in the car. There was one dual SIM cellphone in the car with SIM card nos.9885474699, 7032310975 which were in Anil Reddy's name, hence they were called to P.S. In this case also Prakash Reddy has manipulated this and left the cellphone in the car with the SIM card taken in their name by forging the signatures. In this case Prakash Reddy used one Yakub, Babu Rao and Dharavath Deva Naik of Narlapur (v) Thadvai (m) Warangal to keep the Ganja in Maruthi with the cellphone having SIMs in the name of Anil Reddy and abandon it. Later Maredmilli police arrested Deva Naik and Yakub, Babu Rao and Prakash Reddy are wanted in that case.

SOT Rachakonda on credible information apprehended Prakash Reddy on 10-04-17 in Cr.No.253/17 of Malkajgiri P.S and during enquiry he confessed of the above offences.

The arrests were made under the supervision of Sri K.Narsing Rao, Inspector of Police, I/c SOT Rachakonda by Sri P.Anjaneyulu, and staff of SOT Rachakonda and staff of Malkajgiri P.S
