### Two cricket betting gangs nabbed

The sleuths of SOT, Rachakondaon credible information apprehended **two cricket betting gangs** who were operating in Ibrahimpatnam and Kushaiguda P.S limits and betting money on IPL cricket matches. Total 10 persons including organisers were nabbed and an amount of Rs.9,90,500/-, one laptop and 13 cellphones seized from their possession.
