The sleuths of CCS, LB Nagar with the help of Vanasthalipuram Police of Rachakonda Police Commissionerate have made sincere efforts and apprehended today on **12-11-2018** one Habitual Offender by name **A1.Mohammed Amer @ Amir @ Prince S/o Late Mohammed Khadeer, Age: 26 years, Occ: Glass Fitter, R/o Baba Nagar, Opp: Aliya Garden, Chandrayangutta, Hyd. A2. Syed Taufiq S/o Zavar, Age: 30, Occ: Gold Polish Work, R/o Sadath Nagar, Kandikal Gate, Chandrayangutta, Hyd** under suspicious circumstances at FCI Colony. On questioning he revealed his Criminal record and also confessed the following offences.

This offender first time arrested by Chikkadpally Police in the year 2014 where he was involved in 18 cases of Cyberabad & Hyderabad. Later PD Act was initiated against him to curtail his activities. After his release he was again involved in Chain snatching offences and arrested by Thukaramgate Police. Last time he was apprehended by Gandhi Nagar Police and executed NBW and sent him to judicial custody.

He was released from jail on 11.09.2018. After release again he continued his old criminal path.
