5 Motor Cycle offenders and receivers nabbed by the Kushaiguda Police 47 motor cycles recovered. 28 cases of Rachakonda, Cyberabad detected. Gang of professional motor cycle offenders **1: Dara Bhaskar**, S/o Yellaiah, Age: 28 years, Occ: Gramapanchayat worker, R/o Jagdevpur (V & M), Siddipet District and **2: Upunithala Santosh**, S/o Chandraiah, age: 20 years, Occ: Auto driver, R/o Teachers colony, Jagdevpur (V & M), Siddipet (District), who has committed **Automobile thefts** in the limits of Rachakonda and Cyberabad Commissionrates, apprehended by the crime team of Kushaiguda. In view of frequent Automobile thefts in the limits of Kushaiguda, a special team was formed to track down the movements of the offenders, with the strenuous efforts made by the Police, Kushaiguda under the supervision of the DCP, Malkajgiri Zone and ACP, Kushaiguda Division, on 30.08.2018 at 2100 hours apprehended.

A1 has committed 47 two wheeler (Auto mobile) offences in the limits of Kushaiguda PS, Jawahar Nagar PS, Neredmet PS, Ghatkesar PS, Bhongir Town of Rachakonda Commissionerate and Alwal PS of CyberabadCommissionerate and the A2 is an associate to A1 and A2 involved in as many as in 6 cases. Basing on their confession recovered **total 47 Motor Cycles** from the accused persons and as well as arrested the receivers who received stolen motor cycles from the accused persons.

A3: GurjakuntaParamesh, R/o Mandapuram, Pallugadda (V), Jagdevpur (M, Siddipet District has received total **(11)** Motor cycles

A4: Sheripally Ganesh, R/o Kondapur (V), Jagdevpur (M), Siddipet (Dist) has received total **(11)** Motor cycles

A5: UchantalaMallesh R/o KondetiCheruvu (V), Rajapet (M), Yadadri District has received **(06)** Motor cycles.

The total worth of All motor cycles is Rs. 22,00,000/- (Rupees Twenty Two lakhs)
