FIVE MEMBER BURGLARY GANG NABBED BY SOT, RACHAKONDA WORTH GOLD & SILVER ORNAMENTS WORTH RS. 5,80,000/- FROM THEIR POSSESSION

On 23.11.2018, the sleuths of Special Operations Team, LB Nagar Zone Team, Rachakonda Commissionerate, nabbed a notorious habitual Burglary offenders Shaik Yousuf Basha, Karamtothu Santosh, Pandith Suraj along with two receivers and detected 06 cases of HB by Day & Night reported in the limits of Rachakonda Commissionerate and recovered 160 Grams of Gold & 1 Kg of Silver Puja articles, two mobile phones, One Mahindra Dio bike all worth Rs. 5,80,000/- from their possession .

They conduct recee by moving on their vehicle in the day time and at night time they commit theft of Gold, Silver and other valuable items from the houses.

The accused A1) Karamtothu Santosh & A2) Pandith Suraj gave the stolen property to A3) Latchiram & A4) Vankudothu John, at low price and collected money from them. They were involved in the following cases of Abdullahpurmet police station.
