TWO FRAUDSTERS HELD FOR CHEATING STUDENTS PROMISING TO PROVIDE GOVERNMENT JOBS POSING AS P.A. IN THE SECRETARIAT- CHEATED MORE THAN 20 PERSONS BY COLLECTING 70 LAKHS RUPEES – SEIZED RS 1 LAKH CASH, THREE CARS, ONE BIKE AND (2) MOBILE PHONES ALL WORTH RS 20 LAKHS FROM THEIR POSSESSION.

The sleuths of SOT, Malkajgiri Zone of Rachakonda Commissionerate on credible information apprehended two persons 1.**Mohd.Kifayath Ali** and 2. **Shaik Moinuddin** for cheating students posing as **P.A.** in the secretariat, Government of Telangana and collected more than 70 lakhs of rupees from their parents to provide jobs in government sectors as Deputy M.R.O., Attenders, Transfers of government employees. Police seized **1 LAKH RUPEES CASH, THREE CARS, ONE BIKE AND (2) MOBILE PHONES FROM THEIR POSSESSION.**

ACCUSED DETAILS:

1. **Mohd. Kifayath Ali** S/o Mohd Sadiq age: 29 years, Occ: Private Employee R/o H.No. 19-2-246/H, Abul Hasanath Colony, Kamatipura, Bahadurpura, Hyderabad. N/o Mandi Bazar, Warangal.
2. **Shaik Moinuddin** S/o Shaik Hussain age: 34 years, Occ: Mutton Shop at Pochamma Maidan, Warangal. R/o Mandi Bazar, Warangal.

Brief Fact of the Case:**Mohd. Kifayath Ali** resident of Abul Hasanath Colony, Kamatipura, Hyderabad. N/o Mandi Bazar, Warangal and Shaik Moinuddin resident of Mandi Bazar, Warangal cheated more than 20 persons to provide jobs in government department as Deputy M.R.O., Attender, transfers of the government servants in different wings and collected more than 70 lakhs of rupees from parents of students posing as P.A. in the secretariat, Government of Telangana.

The accused Mohd. Kifayath Ali hatched a criminal conspiracy with A2to cheat the public have printed visiting cards as **Asst.P.A.to Chief Minister Advisor**, Secretariat, Government of Telangana and by keeping name plate as P.A. in the Government Peshi in front of his house and by fitting **Red Light** with siren to the vehicle and pasted sticker as Govt. Vehicle and by employing a private person on monthly salary basis from private securities and making him to wear Safari posing as **gunman** and made people believe him that he is working as P.A. in the CM Peshi and can easily provide jobs to

the post of Deputy M.R.O., Attender in the government departments without writing any examination and also transfers of government employees.

Believing him since 3 years people have approached requesting to provide jobs in the government departments and he has collected about 70 lakh rupees from more than 20 persons and purchased 3 cars, 1) Varna B.No. AP22AE0786, 2) TATA Safari B.No. AP35F 5577, 3)Scorpio B.No.AP9AU 5699 and constructed 3 storeyed building at Mandi Bazar, Warangal and leading lavish lifestyle.

When the victims trying to meet him for enquiry about the job he used to call them to secretariat, camp office and made them wait outside for hours together and he used to go inside and later informing them that he has met the concerned official and they are going to issue the appointment orders at the earliest. When the people got suspicion he shifted his house from Mandi Bazar, Warangal to Kamatipura, Hyderabad and was not responding to their calls.

PREVIOUS HISTORY OF THE ACCUSED: The accused **Kifayath Ali** along with his father-in-law **purnachandar, sneha kumar and sampath all R/o of mandi bazaar, matwada of Warangal district** Hatched murder conspiracy to kill one Prasad R/o Shiva nagar of warangalwho is a son of kifayath ali father in law purnachander concubine and 13.01.2018 they have murdered Prasad by stablign under the limits of **Tadvai Police Stationin Warangal** District. Vide Cr.No. 05/2018 U/Sec 302 r/w 34 IPC.

The accused **1st wife** have also lodged a criminal case against Kifayath Ali in **Delhi**. Both the cases are pending in the courts.

On tip of information, the sleuths of SOT Malkajgiri Zone, Rachakonda along with local police apprehended Mohd. Kifayath Ali and Shaik Moinuddin and seized **1 lakh rupees cash, three cars, one bike and (2) mobile phones from their possession.** They are handed over to LB Nagar PS for taking necessary action.

Further we are trying to secure the victims to book cases against the above persons at their respective police stations. It is also an appeal to the public not to fall prey in the hands of the cheaters as there is no short cut/back door entry into the government jobs and not to lose their hard earned money by paying to the cheaters.
