

WANTED NOTICE IN CR. No. 214/2016,, U/s 302, 380 IPC of Meerpet PS, on

Accused (A-1) Bala Subramanyam

Facts of the case are that on 18.03.2016 at 1830 hrs, received a complaint from Sri Japala Naga Sai S/o Late Sreenivasa Rao, aged about 40 years, Caste OC Brahmin, Occ. Private School Teacher at St. Joseph's School. Ramanthapur, R/o Plot No. 68, Vekatadri Nivas, Badangpet Village, Saroor Nagar Mandal, Ranga Reddy District wherein he stated that on 18.3.2016 at about 0830 hrs as usually he along with his wife and brother left the house to attend their routine duties. An auto driver took his elder daughter Sai Sriharsha, aged about 10 years, who is mentally disabled to her school and brought her back to the house at 1615 hrs, and noticed that his mother Smt. Japala Naga Laxmi, aged about 64 years found dead in the hall in a pool of blood. Immediately the auto driver informed the same to the owner of the auto, who in turn informed the same to his wife over phone and on that his wife informed the same to him. Immediately, he rushed to the house and found that his mother was lying dead in a pool of blood, by strangulating with her saree. The Gold ornaments i.e. Pustela Tadu, Ear Rings and Silver anklets were not found on her body. He suspects that some unknown persons gained entry into the house, killed his mother and stolen away gold ornaments from her. Complainant requested to take necessary action.

On receipt of the above complaint, SHO, Meerpet PS registered a case in Crime No.214/2016, U/Sec 302, 380 IPC and took up the investigation.
