

PRESS NOTE

APPREHENDED ONE ACCUSED WHO KILLED AN INNOCENT OLD AGED WOMAN AND STOLEN HER GOLD AND SILVER ORNAMENTS AND RECOVERED ALL THE PROPERTY i.e. 6 TULAS OF GOLD, 10 TULAS SILVER BANGLES AND ONE MOBILE PHONE OF THE DECEASED INTACT ALL WORTH RS.1,23,000/- FROM HIS POSSESSION.

CR.NO.23/2020, U/S 302, 379 IPC OF KANDUKUR PS, RACHAKONDA

The sleuths of staff of Kandukur PS, CCS & SOT LB Nagar have made sincere efforts and today i.e. on **28.01.2020 at 1700 hours** apprehended the accused **KALYANKAR BHAVANJEE S/o: Late Ramchander Age: 36 yrs Caste: Arre Katika Occ: Security Guard (Vijaya Krishna Spice Pvt Ltd, Bairagiguda Kandukur) R/o: Nedunur Village of Kandukur Mandal at Nedunoor X road** who confessed to have committed the offence.

BRIEF BACK GROUND OF THE OFFENDER – The accused **Kalyankar Bhavanjee**, is having bad habits by addicting to alcohol and his salary was not enough, his wife has took fight with him and left him and went to her mother's home 7 years ago. The accused to full fill his desires and he decided to commit theft by murder and by taking the lenience as the deceased is neighbour cum old age person, the **deceased Balamani, age: 80 years** used to visit to the house of the accused to spend time with the mother Rukkum bai, age: 80 years of the accused who is also of same aged group. So he decided to murder her as it is easy way theft and to earn money, so he committed this offence.

COMMISSION OF OFFENCE: On 27.01.2020 at 1630 hours the accused offered the deceased for consuming toddy when the **deceased Balamani** was sat alone on Gangula Mallamma's couch near Syndicate bank of Nedunur Village, at about 2000 hours the deceased went to the accused house, on that the accused gave 2 packet toddy to her and she consumed toddy at the time no one was present in his house then he decided to commit the theft of ornaments and at about 2100 hours he came behind the deceased and he throttled her with his hands even after she tried to escape from him but he continued his effort as such she died. Immediately he committed theft of 2 rows of gold chain(3 Tulas), gold gundlu chain (2 Tulas), ear ring mati (1 tula) and silver bangles(10 Tulas) and a phone and hidden the same in the toilet basin of his house later he dragged the dead body and thrown in front of her daughter house.

INVESTIGATION: On receipt of the information of Murder for Gain, the Kandukur PS, CCS & SOT LB Nagar teams immediately pursued the investigation and enquired with the complainant and the neighbours and local sources and on enquiry it has come to light that the accused who resides nearby the house of the deceased was found suspicious. Immediately he was taken into custody and on thorough questioning the accused admitted his guilt in which

the accused called the deceased to his house and they both were consuming Alcohol & Toddy in the mean time the accused throttling the deceased and snatched her 6 thulas gold ornaments, silver bangles and a Samsung mobile phone and he the hidden stolen property at his home toilet basin. The above mention staff apprehended the accused and recovered the stolen property ***INTACT***.

This case was detected by the staff of Kandukur PS, CCS & SOT LB Nagar teams at the place of offence under the direct supervision and leadership of **Sri. Mahesh M Bhagwat, Commissioner of Police and Sri. G Sudheer Babu, Addl. Commissioner of Police Rachakonda**, with the guidance of **Sri. Sunpreeth Sing, IPS, DCP LB Nagar, Sri. Yadagiri, DCP Crimes and Sri. D Srinivas Addl. DCP Crimes. Sri. Yadagiri Reddy, ACP Ibrahimpatnam**. The following team involved in Investigation i.e. Inspectors, P. Ashok Kumar, Sri E Jangaiah, Sri Venkanna Nayak and Sri D Praveen Babu and CCS LB Nagar team along with Kandukur Police apprehended the accused and detected **(1) Grave Case** and recovered **INTACT** property all worth Rs. 1,23,000/-.
