BRIEF HISTORY OF ACCUSED PEROSNS: - A1 Ponnala Shiva Shankar is an old offender. Earlier he used to work as Auto Mechanic, and committed theft of one Auto along with his brother-in-law Miryala Subba Rao in the year 2005. In this case he was arrested by Palvanacha PS and sent to Bhadrachalam Jail. After released from the jail, his relative Miryala Satyanarayana formed a burglary gang with four members, including A1 Ponnala Shiva Shankar. They committed house burglary offences in the limits of Palvancha, Bhdrachalam and Kothagudem Towns and arrested. Thereafter he along with the Pandiri Venkateshwarlu committed property offences in Khammam town and arrested. Again he committed offences in Palvancha Town along with Trupathi Rao, in these cases also arrested by Palvancha police and sent to Khammam jail. After released from jail contacted Venkanna and other members over phone, and committed series of offences, in those cases Kothagudem II Town Police arrested and imposed PD Act on A1 & A2 by Kothagudem II Town Police Vide PD Act RC.NO. C1/1925/2019 Dt.21.05.2019. After released from jail came to Hyderabad and stayed at Parshigutta and started committing offences.

released and contacted A2 through phone and proposed his plan to commit property offences in Hyderabad surrounding areas. They started executing there plans from December -2019 ending.
