BRIEF FACTS OF THE CASE:-

Facts of the case are that on 23.11.2020 at about 23:15 hours received a complainant from Sri Vasagoni Venkataswamy S/o V. Mallaiah(Late), Age:56 years, Occ: Bussiness, Caste: Goud, R/o: H.No-5-102, KindhiBasthi, Yapral, Malkajgiri, Medchal District and he locked his house his wife and his family members went to Kandikal Gate, Hyderabad to attend relatives Bridegroom ceremony. After returned to house found In the store room all things are fallen on the floor and one almirah was found open in the Master Bedroom. Further the complainant stated that on the verification he found that some unknown offenders gained entry into his house by opening the centre lock and later they found of Gold Ornaments, Silver Ornaments and net cash were stolen from his house.

During the investigation the CCS Team and with help of IT team verified the CC Footages at complainant's house, surrounding places and identified the accused Sony. On credible information i.e. on 27.11.2020 at about 0900 hours apprehended the both the accused Sony and her mother Nemuri Leelavathi and recovered the stolen property from their possession.

History of the case: The complainant Venkatswamy Goud and his three sons 1. Venu 2. Vikaram and Vishwanath were doing toddy business and living as joint family at H.No. 5-102, Kindhi Basthi, Yapral, of them the younger son by name Vishwanth got married with one Sony in the year of 2016. At the time of Sony's marriage her mother Leelavathi mortgaged one plot for Rs. 30 Lacks and the amount spend for Sony's Marriage and facing the financial problems to re-pay the mortgaged amount. To overcome these financial problems A2. Leelavathi hatched a plan and suggested her daughter to commit theft in-laws house. As per their plan waiting for opportunity to commit offence with available door key with her. On 23.11.2020 at about 1800 hours the complainant family members went to Kandikal Gate to attend A1 Co-Sister brother's bridegroom ceremony while duly locked the house. The said Sony went to her mother's

residence before four days back by knowing that her in-laws family being went to function on 23.11.20. Al Sony and A2 Leelavathi came to know that the house was locked, as per their plan at about 1915 hours, A1 Sony went to her in-laws house on her scooty and observed surrounding premises and open the gate and stopped the power and entered into the house by open the door lock with keys and opened the one almirah and committed theft of gold ornaments about 44 tulas, Silver ornaments about 15 tulas and Cash Rs 10,500/-and wantedly damaged another almirah by hitting with a stone for diverting the her in-laws family that the offence committed by professional offenders and left the house through side door.
