NABBED GANG OF TWO NIGERIANS FOR INDULGING IN DRUGS SIEZED -16 GRAMS OF COCAINE, 23 GRAMS OF HEROIN AND 1KG OF GANJA, MARUTHI SWIFT CAR BR. NO. AP05AP-9282, NET CASH OF RS.3,000/-, 02 LAPTOPS, 1 PASSPORT, AND 05-CELL PHONES ALL WORTH RS.16.7 LAKHS IN THE INTERNATIONAL MARKET FROM THEIR POSSESSION.

On 31-12-2017, the sleuths of **Special Operations Team, Rachakonda LB Nagar Zone Team and Jawahar Nagar Police conducted joint operation** and apprehended 2 Citizens of Nigeria, who were in possession of Narcotic substances / Drugs i.e. Cocaine, Heroin, Alprazolam, Amphetamine and Ganja in order to sell them to needy customers on eve of New Year celebrations.16 grams of Cocaine, 23 grams of Heroin and 1kg of Ganja, Maruthi Swift Car Br. No. AP05AP-9282, Net cash of Rs.3,000/-2- laptops, 1 – passport and 05-Cell phones worth Rs.16.7Lakhs in the international market which they are likely to sell in the local market have been seized from their possession.

Brief about the accused persons:-

The accused AgubgbueChidiebubeChukwumais native of Lagos state, Nigeria. He came to India on student Visa. In the month of August-2015 and staying in Jawahar Nagar, Hyderabad. He joined B.Sc (MPCS) in P.G. College Secunderabad and R/o. Plot No. 3 & 4B, VEDA StreetNearMaruthi Gardens, Yapral, Hyderabad.

Seized drugs from the possession of AgubgbueChidiebubeChukwuma:-

1) Ganja-1kg, 2) Ganja sachets -9 (each sachet contains 2 grams), 3) Ganja Ciggirates-11Nos, 4) Cocaine 10 sachets and 19 pockets, 5) Heroin sachets 15 Nos, 6) Cocaine Chocolates 6 Nos, 7) disposable syringes 8 Nos. and 8) injectable voils-3Nos.9) and 6) Swift Car Br. No. AP5 AP-9282 7) Passport

The Sunday PriscilliaOluchiUjunwa is native of Enugu state, Nigeria. She came to India on student Visa. She along with AgubgbueChidiebubeChukwumastaying in Jawahar Nagar, Hyderabad. She studying B.Pharmacy in RBVRR College, Hyderabad.

Seized drugs from the possession of Sunday PriscilliaOluchiUjunwa:

1) Cocaine sachets – 15 Nos, 2) Injectable siranjes-5 Nos, 3) Nigerian Passports-5 Nos, 4) Laptop-2 Nos, 5) Mobile phones-5 Nos.

The accused AgubgbueChidiebubeChukwuma and Sunday PriscilliaOluchiUjunwa is procuring the drugs from one Benajamin who is a common friend R/o. Tolichowki, Hyderabad and Native of Nigeria and used to sell to Nigerian and others.They used to procure 1 gram of Cocaine per Rs.20,000/- and sells the same for Rs. 40,000/- to Rs.50,000/- per 1 gram. They used to supply the contraband to the needy customers and earning easy money.They prepared to dispose the same on occasion of New Year 2018.

Today i.e. on 31-12-2017 in the morning hours, on tip off the sleuths of SOT LB Nagar Zone and Jawahar Nagar police intercepted one MaruthiSwift Car Br. No. AP5 AP-9282 while the accused personsabove to move from their residential area to sell the drugs on eve of New year in the possession along with contraband drug i.e. Cocaine, Heroinfurther proceeded to Plot No. 3 & 4B, VEDA Street Near Maruthi Gardens, Yapral, Hyderabad seized above material from their possession.The approximate value of the drugs in the International market is about Rs. 16,70,000/-

APPEAL TO THE PUBLIC:-

Drug causes loss of appetite, Insomnia, Irritability, Lack of conscious, Depression and frustration and also damages the vital Organic systems. Therefore, public are requested not to use any contraband drug and cooperate with Police by giving information regarding such illegal drugs which has challenged our Society for decades now and their effects are eroding the potential for the youngsters of our generation.

Efforts are on to apprehend the other accused involved in this trade. The arrested accused persons along with seized property will be produced in the court of law.
