The sleuths of the Special Operations Team (SOT) of Rachakonda apprehended interstate gang of (05) members cloning International credit cards viz., USA, UK & Australia. One laptop, sixteen POS machines, magnetic card reader, net cashRs. 2 Lakhs recovered from their possession.

MODUS OPERANDI:-

The gang led by IT engineer Ayyappan @ Rajesh (30) had defrauded the foreigners mainly USA, UK & Australia to the tune of over Rs. 30 lakhs till now. Hailing from Nagapattinam district of Tamil Nadu, Rajesh developed friendship with Raghavendra (30) and Vamshi Krishna (28) both native of Andhra Pradesh state through social networking sites.

Ayyappan @ Rajesh worked as commission agent and found not-so-decent. Later he became a member of ICQ app which is an instant messaging app from where he developed friendship / joined the various groups and learnt the knowledge in cloning of credit cards as well as internet and procured the cloning device (MSR606) from e-commerce website.

He used to purchase the data of international credit cards from various sourcesspecially USA, UK & Australia i.e.,32 bit bin / credit card details of foreigners through various internet sites, open sourcesand the same was received / shared through ICQ appas well as received in the group. After getting the data he used to check the same on BIN Checker application, where Bin Checker checks and validate the data viz., type of BIN, Brand, Bank, Card type and country name. After verifying the details of the same he used to send the details through whatsapp to Raghavendra. Who in turn used to write the same on empty magnetic cards specially on promotional cards like Big Bazar, Reliance Digital, Shoppers Stop etc., by using MSR 606 magnetic card writer.

Raghavendra is an engineering graduate (B.Tech, IT) hails from Ongole of Andhra Pradesh state worked for Brigade, Sutherland companies. Left the job and developed friendship with one Rajesh while doing Real Estate Business who is resident of Chennai and learnt how to clone such cards and took training on cloning process and obtained magnetic card reader / writer tool kit (MSR606), data cables from Rajesh established a setup at Vamshi Krishna @ Akhil residence in Chaitanyapuri.

After collecting the details from the Rajesh, Raghavendra used to write them on to empty magnetic strip cards through magnetic card writer. Vamshi Krishna @ Akhil used to collect the POS machines from the different merchants through his sources by offering 20% as commission on total settlement. Raghavendra used to swipe the cloned cards on POS which is having international card acceptance. After completion of this work they use to return the same by collecting their share 20% of cash on total settlement and distribute between themselves. After sale consideration as the amount credit into the bank of the merchant he retain his 20% as agreed by Vamshi, remaining 60% of amount is transferred to various bank accounts of Rajesh as he directed, through RTGS / NEFT in sometime they used to collect the cash and deposits the same throughcash depositing machines into Rajesh accounts.

The gang had cheated the innocent foreigners by cloning the credit card data, swindled their amount using POS machines at various places in Chennai, Hyderabad, Kakinada, Guntur and other cities.

The gang leader who had good knowledge in hacking of data from various websites the same was obtained various sources, various countries he had developed sufficient technical knowledge, using latest software and hardware technology and posed a threat to financial and other institutions. The accused persons along with seized property were handed over to SHO, Cyber Crimes PS, for taking necessary action.

The above arrests made under the guidance of Syed Rafeeq, Addl. Dy. Commissioner of Police, Special Operations Team, Rachakonda, Sri Harinath, Asst. Commissioner of Police, Cyber Crimes, by P. Venkateshwarlu, Inspector of Police, SOT, M. Kashi Vishwanath, SI of Police and the staff of Special Operations Team, Rachakonda under the direct supervision of Sri Mahesh M. Bhagwat, IPS., Commissioner of Police, Rachakonda.
