## SOT POLICE - APPREHENDED TWO PERSONS FOR SELLING COUNTERFEIT SONY, SAMSUNG TELEVISIONS

The Sleuths of Special Operations Team, Rachakonda Commissionerate along with Chaitanyapuri police on credible information conducted raid at HNo. 1-2-124, Road No. 17, Chaitanyapuri, Dilsukhnagar and recovered 50 stickered SONY, 01 Samsung Televisions which were being sold at the price of the original. Duplicate TVs (51 Nos), and a box containing logos and stickers of SONY brand all worth Rs 25,68,500/-, two mobile phones were seized from the house of accused.

Gaurav Singh is native of Delhi, came to Hyderabad on 18<sup>th</sup> March 2018 and established a shop in the premises of H.No. 7-45, (Old), (New), 1-2-124, Road No. 17, Chaitanyapuri, Dilsukhnagar, Hyderabad and uploading photographs of the branded Televisions viz., **SONY Bravia HD, Ultra HD, 4K, 4K Ultra HD, Smart TV, Android TV & Samsung** televisions and luring the customers by offering heavy discounts. He is **procuring the assembled televisions from one Malhotra r/o Delhi**, **who is the licenced assembled television seller**. The accused snickering the assembled televisions as branded and selling on double price till now he has **sold out 30 televisions** to the customers. Prior to this he has established the business in the states of Karnataka &Tamilnadu respectively. The bills will be prepared on the name of TELE RACK! Electronic Private Limits, Address: H.No. 7-45, (Old), (New), 1-2-124, Road No. 17, Chaitanyapuri, Dilsukhnagar, Hyderabad.

A joint raid of SOT Rachakonda along with Chaitanyapuri Police was conducted raid on the house. Posing as a customer to the shop to buy a SONY Bravia. After the raid was conducted, police arrested **owner Gaurav Singh**, **29**, **and salesman Budigaala Santosh**, **30**, under various sections of the Copyright Act.
