ACCUSED HUSBAND ARRESTED IN SENSATIONAL TWIN MURDERS WIFE AND SON IN CR.NO: 302 IPC, Sec.3(2) (v) of SC/ST POA, 2015 OF PS VANASTHALIPURAM PS OF RACHAKONDA

Complainant: Sri Gourarapu Ramesh, S/o. Uppalaiah (late), aged 28 years, Occ: Labour, R/o. near Sivaji Park, Judges Colony, Vanasthalipuram, RR District, N/o. Kothapalli Village, Lingala Ghanapur Mandal, Janagon District. (Elder brother of deceased Smt. Kavitha @ Saba)

Deceased No. 1: Smt. Gourarapu Kavitha @ Saba, W/o. Adib Alam, aged 25 years, Occ: House Wife, R/o. H. No. 3-14-16, Vijaya Sri Colony, Autonagar, Vanasthalipuram, RR District, N/o. Kothapalli Village, Lingala Ghanapur Mandal, Janagon District. (Wife of accused)

Accused Person: Mohd. Abid Alam @ Abid Alam, S/o. Aftab Alam, aged 27 years, Occ: Labour, Caste: Muslim, R/o. H. No. 3-14-16, Vijaya Sri Colony, Autonagar, Vanasthalipuram, RR District, N/o. A/3, Shiv Kunj Apartment, Exhibition Road, Patna, PS: Gandhi Maidan, Saran, Bihar State – 800001

Facts of the case are that on 30.04.19 at 2010hrs received a complaint from elder brother of deceased Smt. Kavitha @ Saba that his younger sister Kavitha married to the accused which is love marriage and her husband who is Muslim changed her name as Saba. On 30.04.19 bad smell was emanating from their portion and on entering into the house, the dead bodies of his younger sister Kavitha and her two year old son namely Irfan were stuffed into empty water plastic drum.

Basing on the contents of the complaint, registered a case in Cr. No. 374 /2019 U/s. 302 IPC and investigated in to. On 08.05.2019 at 05:00 hours apprehended the accused Mohd. Abid Alam @ Abid Alam at Medhcal and recorded his confessional statement and he has voluntarily confessed his guilt of offence.

Brief History of the accused:- The accused is native of Bihar State. He completed his B. Tech in the year 2010-2014 from St. Mary's College of Engg. & Technology, Deshmukhi Village, Pochampally Mandal but some of the backlogs were pending, as that he was stayed his rented room at Indranagar Colony, Vanasthalipuram for clearing the backlogs. When he resided in a rented house at Indranagar Colony, Vanasthalipuram, he had acquaintance with the deceased Kavitha who was residing in a hut beside his portion. The accused's family members did not consent to their marriage, due to they were eloped and living together. Out of their living, they were blessed with a son. The accused was working as labour and used to suspect that the deceased was having external relationship with others when he is absence. On that he hatched a plan since one month that to kill Smt. Gourarapu Kavitha @ Saba and her son and after he flee to his native place and will get marriage with another woman and live happily. As per his plan on 28.04.19 in the absence of co-tenants and house owner, at about 11 AM while his wife was playing with her son, the accused pushed her down and sat on her and smothered her with a towel and pressed her neck and killed her. Then he had

closed the nose and throat of his son and throttled him, due to which the innocent boy also died.

Seized Property: One Towel from the scene of offence.
