**APPREHENDED FOUR PROFESSIONAL TEMPLE THEFT OFFENDERS AND RECOVERED 215 GRAMS GOLD ORNAMENTS, HYUNDAI XCENT CAR REG.NO. AP 39KN 3611, BULLET BIKE, UNICORN BIKE AND GAS CYLINDER AND OXYGEN CYLINDER. ALL WORTH RS. 19,40,000/- FROM THEIR POSSESSION AND DETECTED (01) GRAVE CASE & (09) NON-GRAVE CASES.**

The sleuths of CCS LB Nagar team, IT Cell-Rachakonda along with LB Nagar Police of Rachakonda Police Commissionerate have made sincere efforts today i.e. on **22.01.2022 at morning hours** apprehended four professional temple offenders along with Xcent Car under the suspicious circumstances while vehicle checking at LB Nagar PS limits, on questioning they revealed their names and also confessed the commission of following property offences. **The Rachakonda Police timely got clues and arrested this gang. Thus averted major bank/ATM/Jewellery shops break openings as the Gang already in preparation by procuring oxygen cylinder, gas cutter and other etc., in order to break open strong cash/jewellery chests. The said above implements have been seized during their arrest.**

**BRIEF HISTORY OF ACCUSED:** –The offender **A1: Ponnuri Chinna Satyanandam @ Sathish** earlier he was arrested by Nagarjuna Sagar police, Manglagiri police and Donakonda Police. He was also arrested in “**Arms Act**” by Donakonda of Guntur Police and recovered a **Pistol**. **A2: Daravath Naveen** is a B.Tech student and also an old offender earlier he was arrested in NDPS act by Miryalguda Rural PS. **A3: Gandam Sammaiah** is arrested in illegal liquor sale case by Gurajala police of Guntur Dist., **A4: Jangala Prasad & A5 Mandla Nagendar** were arrested in a rape case and sent them to Gurajala Jail and all of them formed a group in the jail and committed theft of all these offences to gain easy money.

**MODUS OPERANDI (M.O)** :- The offenders commit theft of cars and motorcycles later change it's number plates. They used to recce the temples during day time by stolen car and hatch a plan to theft of gold & silver ornaments and flee away by avoiding tollgates for not disclosing their identity.

**BRIEF HISTORY OF CASE:** On 03.12.2021 at around 2230 hrs the complainant Sri Kumbari Madhav Maharaj went to his house by locking the temple after the rituals. On 04.12.2021 at around 04.30 hrs the complainants relative namely Ravi reached temple and intimated to the complainant about theft, then immediately he reached the temple and found that Temple's Main door lock was broke opened by unknown offenders and committed theft of gold ornaments 1) Kasulaperu- 5 Tolas, 2) Long Chain - 4 tolas, 3) Ruby Necklace - 3 tolas, 4) Gundlaperu - 03 tolas, 5) Small Necklace - 02 tolas, 6) Small necklace of White stone - 1.5 tolas, 7) Ear Rings - 3 tolas (**Totally wg. about 21.5 tolas**).
