

PRESS NOTE

INTERSTATE DRUG PEDDLERS NABBED BY HAYATHNAGAR POLICE OF RACHAKONDA COMMISSIONERATE AND SEIZED 470 KILOGRAMS OF CONTRABAND GANJA, 4 CARS AND NET CASH OF RS 2 LAKHS ALL W/RS.1.20 CRORES RECOVERED FROM THEIR POSSESSION

Acting on specific information, the sleuths of Hayathnagar Police of LB Nagar zone busted an interstate drug syndicate by apprehending Ten interstate drug peddlers viz., Rahul, Cherukupalli Srikanth @ Kannaiah, Shaik Nawazuddin, Rathod Vinayak, Banavath Kishan, Gowlikar Sai Ajay, Sainath Chowhan, Ms. Jeripothula Ravali, Domati Sangeetha and seized Contraband Ganja – 470 Kgs, Four Cars i.e., 1] TS 08 HT 0639 (Breeza), 2] KA 38 M 8508 Verna, 3] TS08UD 1588 (TATA BOLT), 4] TS08FJ 4244 (i-20) Mobile Phones-11 Nos. Net cash Rs 2 LAKHS all W/RS.1.20 CRORES from their possession.

Brief Facts:-

The accused Ashok Kumar r/o Sidhal Thanda, Bidar along with Nawazuddin ShaiK, Vinayak, Kishan and Naga have indulged in illegal transportation of Ganja since past few years. They are having good contacts with the Ganja buyers from other states viz., A.P, Orissa, Karanataka, Maharastra state. They are procuring Ganja from Agency areas of East Godavari Dist, Donkarai Village & Mandal Agency area of Andhra Pradesh State and other places at cheaper rates and selling the same to the prospective customers of other states for higher price. He along with his associate Rahul Srikanth are involved into the illegal transportation of Ganja and earning easy money.

On 22.05.2022 the accused Cherkupally Srikanth, Sai Nath Chowhan, Sai Ajay, Ravali and Sangeetha went to interior village Donkarai Agency area of East

Godavari district, in two cars viz., Brezza and I-20, met A1 Naikam Rahul and procured 470 kgs of Ganja (235 packets- 2KGs each) from one A5 Raju and A6 Sanyasi Rao for Rs.3,000/- per kilogram for onward transportation to the prospective customers at Mumbai for Rs. 20,000/- per kilogram. As per their plan the said vehicles left from Donkarai of EG Dist to reach Mumbai via Hyderabad. While they are on the way after reaching outskirts of Pasumamula village near ORR beside Hills, the accused stopped their cars and while shifted the Ganja packets into other two cars of the accused Nawazuddin ShaiK, Rathod Vinayak, Kishan, in the meantime on 22.05.2022 evening hours the Hayathnagar police intercepted their vehicle at above place on credible information.

A4 to A5 is having past history of peddling Ganja, A2 Srikanth get into contact with A1 from the old offenders from Cherlapally Jail and indulging in illegal transportation of the Ganja. We come to know that A2 has transported 100 kgs Ganja in the last (20) days from Daonkarai to Jaheerabad and handed over to A3. Police is investigating the case to find out the track of the Ganja being transported to various states.
