# TWO INTERSTATE OFFENDERS HELD FOR COMMITTING THEFT OF SANTOOR SOAPS ALONG WITH LORRY FROM MAHESHWARAM TOTAL W/Rs 38.5 LAKHS SOAPS AND 15 LAKHS WORTH LORRY RECOVERED

### **Brief Facts:-**

On 02.07.2022 Sri Mandeep Kumar, Age: 27 years, transport Manger of Super Safe Logistics, Andhrakesari Nagar Colony, Vanasthalipuram, N/o Rasiwas Village, Bhiwani district, Haryana State, lodged a complaint at PS Maheshwaram, that two persons names Manoj Parmar, Manish Parmar brought Santoor Soaps load from Amalner, Maharashtra from Wipro company hub unloaded at Wipro storage hub Maheshwaram. The complainant contacted both the above persons to transport Santoor soaps load (1300 boxes) from Maheshwaram to Thumkur, Karnataka. On 27/06/2022 at evening hours the driver Abhijeet Mohith, Manoj and Manish Parmar got loaded Santoor soaps W/Rs 39, 76,128/- and left Wipro hub. Later he found load did not reach Thumkur, and when he tried to contact them over telephone, their phone were switched off and requested for necessary action

#### Modusoperandi

The A-1 Rajesh Ved @ Manoj Parmar is the main culprit and man conspirator for the offence Rajesh Ved previously resided in the out skirt of Hyderabad and was into preparation and selling of sweets during that time he came in contact with Sushil Behra @ Abhijeeth N/o West Bengal who was residing at Sanga Reddy and working in Pepsi company since 15 yrs Rajesh Ved incurred loss and he went back to Pune. He decided to committee theft of goods by diverting the loads/goods. from transport company he secured the presence of Sushil Behra@Abhjeet, explained his plan and Sushil Behra agreed the proposal for making easy money with in no time. Accordingly both Rajesh Ved@ Manoj Parmar, Sushil Behra@Abhjeet searched for deserted persons to act as cook and driver. They secured the presence of Pareesh 65 yrs and charged his name as MANISH PARMAR and one VENKAT driver then all the four went to Dhule of Madhya Pradesh state, established a transport office. Under the Banner of Shree Sai Transport, in April-2022 they took a lorry on lease from one Ruknuddin R/o Sendra at Rs 70,000/- per month. In the month of may they transported soaps from Amalner to Maheshwram,. but could not reached as the cost of the loads were below 10 lakhs.

On 27/06/2022 they loaded santoor soaps W/Rs 39,76,128/ only at Wipro hub Maheshwram to unloaded the same at Thumkur of Karnataka State. Enroute after reaching near Rudram village, they stopped the vehilce at Rudraram where Rajesh ved and Sushil Behra searched for vacant shop and they found two shetter at Rudraram they got unloaded the stocks in the said two shutter and again they came back to Maccha bollaram area where Rajesh Ved is persons contact and took two rooms rent and shifted the above Stock from Rudraram to Maccha Bollaram through local transport Autos and disposed about 188 boxes to various shops at cheap rate (3000 per box)

While making efforts on 14/07/2022 early hours the accused Rajesh Ved @ Manoj Paramar and Sushil Bera@ Abhijeet were arrested and the stolen lorry B.No. MH19Z 4299 along with 1112 Soap boxes, one Honda Active, Net Cash 1,55,000/-etc., were recovered from at their possession.

The accused wanted to earn easy money with in no time and committed theft soap load along with lorry.
