On credible information, the sleuths of Special Operations Team (SOT), LB Nagar Zone team along with Jawahar Nagar police busted drug racket by apprehending two interstate drug peddlers.

Brief Facts:-

The accused Oma Ram and Sanwala Ram are native of Rajasthan State and eking their livelihood by doing Carpenter & SS Railing Works. Due to financial problems, they decided to earn easy money by selling of Narcotic Drugs. A few months ago, they came in contact with one Vikas @ Mukesh N/o. Madhya Pradesh State who is a drug supplier since than they started purchasing of Poppy Straw drug

and MDMA from Vikas @ Mukesh through public transportation vehicles (Buses, Lorry, Auto's etc) and selling it to needy customers in and around of Hyderabad City.

On 21.07.2024, evening hours, on tip off information, the SOT LB Nagar team along with Jawahar Nagar police apprehended the accused persons near Malkaram Village outskirts heading towards Thimmaipally (V), Keesara under the limits of Jawahar Nagar police station and seized (40) KGs of Poppy Straw, (10) grams of MDMA, Net Cash Rs.10,000/- (03) Mobile Phones and other incriminating material from their possession. Efforts are afoot to apprehend the absconding accused. The main peddler and source not available for examination. Efforts are afoot to identify the receivers in and around Hyderabad and apprehend the absconding accused and also to identify the consumers.

It is an appeal to the people and students that procuring, selling, transporting and consumption of the banned Narcotics substances and drugs is a crime and punishable for imprisonment for a period of 10 years and also death, according to Section 31 A of the NDPS Act. Further requests the society to help police in curbing the menace.
