# ACCUSED INVOLVED IN A THEFT CASE IS ARRESTED BY THE CHOUTUPPAL POLICE

## Cr.No. 533/2024, U/s 303 (2) B.N.S OF P.S CHOUTUPPAL, RACHAKONDA.

On 09.08.2024, the sleuths of Choutuppal Police, Yadadri Bhuvanagiri Zone, Rachakonda Commissionerate, nabbed one person at Adhaya Hotel, NH-65, Malkapur, Choutuppal under the limits of Choutuppal police station. Seized (1832 Grams) gold ornaments all worth Rs. 1,26,88,432/- from his possession.

### FACTS OF THE CASE:

On 28.07.2024 received a complaint from Sri Kunal Kotari S/o Dileep Kotari, age: 35yrs, Caste: Jain, Occ: Sales Manager in AD Jewelleries Aram mall, 503, Jaweri Bazar, Mumbai, R/o Jawahar Nagar, Goregav west, Mumbai, Maharashtra State, in which he stated that he is engaged in the gold business in Mumbai, Pune, and Andhra Pradesh under the name *AD Jewelleries*. On 26.07.2024 he gave gold ornaments i.e., 1) 30 pieces of black beads weighing 609.250 grams, 2) a necklace weighing 20.380 grams, 3) 7 pieces of black beads weighing 125.40 grams, 4) 30 pieces of black beads weighing 358.430 grams, and 5) a haram with 10 pieces and a necklace with 6 pieces weighing a total of 987 grams, making a total weight of approximately 2.1 kilograms to his employee named Purohith Bharath Kumar S/o Samardharam. The complainant boarded his employee on board of Orange Travels bus, registration number AP-02-A-9687, at Chunaabatti bus stop to deliver the gold items to the AD Jewelleries branch in Andhra Pradesh. On 27.07.2024, at 09:30 hrs, when Purohith Bharath Kumar reached near TAZZOE KITCHENS on NH-65 in

Dharmojigudem, Choutuppal Mandal, Yadadri-Bhuvanagiri District, he left the bag containing the gold ornaments on the bus and went out to get tea. After 20 minutes, when he returned to the bus and checked the bag, he found that the box containing the gold ornaments was missing.

Basing on the complaint registered a case and investigation into. Formed four teams and sent to Karnataka, maharastra and Madhaya Pradesh states.

#### MO:

The accused persons who are well knowing about the transport of the Gold from Mumbai to other states and they follow such persons who carry and ship the gold for delivery and when the bus halts for lunch, breakfast, dinner they enter into the bus and commit theft of the bag of the passengers

After committing the offence, they escape by using fake number plates for their vehicles. Mainly Orange Travel buses are their targets.

Yadagiri, SIP of Police Choutuppal, Sri. Taqiuddin, SIP Thurkapally Police Station, Sri. G. Srinivas, HC Bommalaramaram Police Station and staff of Choutuppal team.
