

## PRESS NOTE

### BURUST OF INTER-STATE CHILD SELLING RACKET BY THE MEDIPALLY POLICE, RACHAKONDA COMMISSIONEATE AND RESCUED (11) BABIES

On 22.05.2024, as per the complaint of Sri. Manyam Sai kumar S/o Sathyamurthy, age: 30 yrs, Occ: Reporter, rescued one Baby girl along with accused A1) Shobarani, 2) Swapna, 3) Shaik Saleem. A case in Cr no. 579/2024 U/s 370, 372,373 r/w 34 IPC, Sec 81,87,88 J.J.Act-2015, of PS Medipally. On interrogation of A1, she stated that she is in coordination with 2) Hari Hara Chetan, she is selling the babies, The A1) Smt. Shobarani A2) Swapna, A3) Shaik Saleem were arrested on 22.05.2024 and sent to J/C.

As per the confession statement of the above accused and based on the information received the following accused were arrested yesterday i.e., on 27-05-2024.

A7	Mudavath Sharadha @ Shakeela Pathan, age: 39 yrs, caste: ST-Lambada, R/o: Vijayawada.
A8	Mudavath Raju s/o: Saviya, age: 30 yrs, occ: Driver, caste: ST-Lambada, R/o: Bayyanna Nagar, Uppuguda, N/o: Banala (v), Balmur (M), Mahaboob Nagar.

Further on interrogating them, it is elicited that they are used to get the babies from 1) Kiran, 2) Preethi, who are from Delhi, 3) Kannaiah from pune, nearly 50 babies were supplied to the above said accused who in turn give to their agents who used to sell them to the persons who are in need of babies in AP & Telangana in different places, with a price ranging from 1,80,000 to 5,50,000/- per baby with the help of mediators and they used to receive nearly 50,000/- to 1,00,000/- for each baby as a profit in the process of selling. Till now (11) Babies were rescued from the custody from the alleged accused in co-ordination with the CWC of which (2) are have been sent to Shishuvihar for safe custody. The remaining accused 1) Kiran, 2) Preethi, 3) Kannaiah and others were found absconding.

**Previous history of the accused:**

The **A5: Bandari Padma**, is previously involved in Cr No: 39/2021 U/s: 420 IPC, 81 of JJ Act of PS-Ghatkesar and she was arrested and sent to J/c.

The **A6: Balgam Saroja**, is previously involved in Cr No: 81/2024 U/s: 370 (4), IPC, Sec 81 of J.J.Act of PS Munagala of Suryapeta District and she is in absconding in the above case.

The **A7: Mudavath Sharada**, is previously involved in 1) Cr No: 52/2022 U/s: 370 IPC, Sec 81 of J.J.Act of PS Inthegar Gunj of Warangal District, 2) 327/2022 U/s: 370, 120-B, Sec 81 of J.J. Act of Eluru-2 Town PS., 3) Cr No: 112/2024 U/s 370, r/w: 34 IPC, Sec 80,81, of J.J.Act-2015 of PS Kanjumarg PS, Mumbai (Absconding)
