FOUR DRUG PEDDLERS NABBED BY SOT BHONGIR ZONE, RACHAKONDA SEIZED 294 KGS OF GANJA (NARCOTIC SUBSTANCE), TWO CARS, MOBILE PHONES- 02 NOS, NET CASH RS.8500/-FROM THEIR POSSESSIONALL WORTH RS. 43,85,000/-

On 09.01.2022 at afternoon hours, acting on specific information, the sleuths of Special Operations Team (SOT), Bhongir Zone along with Ramannapet police apprehended four interstate drug peddlers viz., 1) Vadthyavath Tirupathi 2) Vadthyavath Kalyan, 3) Panchavath Ravinder @ Ravi and 4) PathlavathManktha and seized (294) Kgs of Ganja, Mahindra Marazzo, Swift Dzire car and Two Mobile Phones and Net Cash Rs. 8,500/- all worth Rs. 43,85,000/- from their possession.

## **Brief Facts:-**

The accused A-1 Vadthyavath Tirupathi and A-4 Vadthyavath Kalyan are own brothers. A-2. Pathlavath Manktha is distant relative and A-3. Panchavath Ravinder @ Ravi all are friends. Vadthyavath Tirupathi was earlier involved in Excise Act in the limits of kalwakurthi in the year 2020. After that, he was doing cab driver in Meeru App service work as Shamshabad Airport to Hyderabad City, in which one year back he purchased a Maruthi Swift Dezire Car Br.No: TS 07 UE 9273 from one Srinu, R/o Thurkayamjal in finance basis and doing his work. In a while, the government conducted lockdown in veiw of Covid due to which he didn't get work and struggling with financially. In few of his financial crushes, and decided to smuggling the Ganja in the Telanga state which was banned by the government to fulfill his financial crushes, about 25 days back he was engaged by unknown person of Maharastra state for driving and went to Rampachodavaram of Andhra Pradesh state, in an Innova vehicle where the owner of Innova vehicle purchased the ganja from A-5. Bapuji @ Buchibabau and delivered in Hyderabad for which he got Rs.20,000/- for his driving. At that the time the Ganja smuggler A-5 Bapuji @ Buchi Babu was introduced him and advised the A-1 to do the Ganja business to get more benefits, mean time A-1 collected the phone number of A-5. Bapuji @ Buchibabau who is still continuing in dry Ganja Business, and decided to smuggling the dry Ganja to earn money in easy, he purchasing the dry Ganja 2 kg packet an amount of Rs. 2000/- in Agency Rampachodavaram and selling the same in Telangana for an amount of Rs.10,000/- per 2 kg packet, he hatched a plan with his friends A-2. Pathlavath Manktha, A-3. Panchavath Ravinder @ Ravi and his brother A-4. Vadthyavath Kalyan to earn money in easy and illegal by selling Ganja for this, they contributed and secured an amount of Rs. 1,20,000/-.

Likewise as per their plan on 07.01.2022 they all are took one Mahindra Marazzo vehicle bearing No. TS 07 UG 8017 on rent basis from one Pathlavath Raju who is brother of A-3 and took the shift Dzier car bearing No. TS 07 UE 9273 of Vadthyavath Tirupathi and proceeded to Rampachodavaram of Andhra Pradesh state, and purchased the Dry Ganja from A-5. Babuji @ Buchi Babu and A-6. Karam Surendra Dara total 294 Kgs contains 147 packets dry Ganja with an amount of Rs.1,00,000/-. The remaining amount Rs. 2,00,000/- will be given to A-5 after selling the Ganja at Hyderabad. Accordingly on 08.01.2022 in the mid night they loaded the Ganja 147 packets in Mahindra Marazzo vehicle bearing No. TS 07 UG 8017 and left from there with the escorting of shift Dzier car bearing No. TS 07 UE 9273 and proceeded towards Hyderabad side, when they reached at Tollplaza Choutuppal they observed police check post Tollplaza, to escape the check post they proceeded towards Ramannapet side at time they apprehended by Ramannapet police.

The above raid was conducted under the supervision of Sri Mahesh M. Bhagwat, IPS., Commissioner of Police, Rachakonda Commissionerate, by P. Yadagiri, IPS., Dy. Commissioner of Police (Crimes), I/c. Special Operations Team, Rachakonda, H. Venkateshwarlu, Inspector of Police, SOT, Bhongir Zone, Ch. Mothiram, Circle Inspector of Police, Ramannapet PS and the staff of Special Operations Team, Bhongir Zone and local police.
