

## **PRESS NOTE**

### **ONE INTERSTATE DRUG PEDDLERS NABBED BY BHUVANAGIRI RURAL POLICE ALONG WITH SOT LB NAGAR ZONE OF RACHAKONDA WHILE TRANSPORTING GANJA FROM ODISSA STATE AND SEIZED 106 KGS OF CONTRABAND GANJA, ALL W/RS.16 LAKHS.**

Today i.e., on 01.07.2022 in the early morning hours, on receipt of credible information, the sleuths of Special Operations Team (SOT), LB Nagar Zone along with Bhongir rural Police nabbed one person name Makka Krishna S/o Makka Narayana Rao, aged 35 yrs, Occ: Scrap Business, R/o Chintur village, East Godavari dist of AP State. N/o. Srikakulam district while he is transporting the contraband drug i.e., Ganja from Odissa state in order to transport the same to needy persons. Seized (106) KGs of Ganja, Net cash Rs.10,200/- and (01) mobile phone, all worth about Rs. 16 Lakhs from his possession.

#### **DETAILS OF ACCUSED PERSONS:**

A:-1 Makka Krishna S/o Makka Narayana Rao, aged 35 yrs, Occ: Scrap Business, r/o. Chintur, East Godavari dist, N/o. Srikakulam district of AP State

A:-2 Ramu R/o Pappalur village, Orissa State (Not available for Examination).

#### **SEIZED MATERIAL:**

1. Contraband Ganja (106) KGs
2. Net cash pf Rs. 10,200/-
3. Mobile phone - 01

Total W/Rs. 16 Lakhs/- (Sixteen Lakhs rupees only)

#### **Brief Facts:-**

The accused A-1: Makka Krishna is resident of Chintur village, East Godavari dist. and eking livelihood by doing scrap business. While doing his business he came in contact with A-2: Ramu r/o. Rappalvillage in AOB Border of Odissa state who is a Ganja peddler and having good contacts with the Ganja buyers in other states. A-1 Makka Krishna is facing financial problems and decided to earn easy money by doing illegal business of selling Ganja. Meanwhile A-1 Ramu offered him to do illegal Ganja transportation and promised to give amount Rs 20 to 30 thousand rupees as commission for transportation, upon which A-1 Krishna accepted A-2 Ramu's Plan and starting illegal transportation of Ganja.

As usually on 30.06.2022 in the morning hours A-1 Ramu handed over (106) KGs Ganja (49) Packets along with one trolley Auto and driver with instructions to hand over the same to a party in the outskirts of Hyderabad.

Today i.e. on 01.07.2022 in the early morning hours the trolley dropped him at Rayagiri X roads, under the limits of Bhongir Rural PS limits and left, while A-1 Krishna was waiting for the instruction of A-2 along with Ganja to hand over to buyers, early morning hours on tip off information of Bhongir Rural police along with SOT LB Nagar Zone Team, apprehended the accused person at Rayagiri X roads along with contraband seized 106 Kgs of Ganja, one Mobile and net Cash Rs 10,200/- from their possession.
