APPREHENDED THREE NOTORIOUS INTER DISTRICTS HABITUAL OFFENDERS OF TRANSFORMER COPPER COILS THEFT AND SEIZED NET CASH RS: 1,00,000/-, 60 KGs OF TRANSFORMER COPPER COILS & WIRE, ONE TATA INDICA CAR, ONE BAJAJ PULSAR MOTOR CYCLES, FOUR MOBILE PHONES AND TOOLS FROM THEIR POSSESSION AND DETECTED (173) CASES.

The sleuths of CCS, LB. Nagar team along with Bhongir Rural Police of Rachakonda Police Commissionerate have made sincere efforts with help of IT Core Team. On **04.05.2023 at 16:00 hrs** apprehended (03) transformer coil theft offenders in TATA Indica car under the suspicious circumstances at Raigiri X Road of Bhongir Rural PS limits, on questioning they revealed their names and also confessed the commission of following property offences:
