DETECTED SENSATIONAL DOUBLE MURDER CASE AND ANOTHER MURDER CASE BY KANDUKUR POLICE – HELD ONE ACCUSED

Acting on Technical evidence and specific information, the sleuths of **Kandukur Police, Maheswaram Zone, Rachakonda** Commissionerate detected Double murder case and another murder case and arrested the accused in Cr.No.237/2024, U/s 103(1) BNS and Cr.No. 79/2023 U/s 302 IPC of Kandukur P.S respectively.

Details of the Cases

1.Cr.No. 237/2024, U/s 103(1) BNS of Kandukur PS.

Facts of the case are that, on 16.10.2024 at 10:05 hours, received a complaint from the complainant, where in, he stated that he owns a mango orchard measuring about 8 acres in Sy. Nos. 595 and 598, located in Kothaguda village. He had employed a couple, **Mooga Ushaiah** and his wife **Mooga Shanthamma** to

attend the works in mango orchard and perform other agricultural work. As usual, on 16.10.2024 at 06:30 hours, the complainant called Ushaiah for couple of times, when he did not answer the call, he made calls to mobile phone of Shanthamma, when she too did not attend the call, he contacted one K. Mahender, R/o Kandukur village, who used to attend the agriculture work like ploughing etc., in his farm and informed him about not attending his calls by Ushaiah and his wife and requested him to visit the farm and appraise the details. Around 08:00 AM, Mahender visited the farm and found Ushaiah's dead body in a pool of blood in the mango orchard with cut injuries and he also noticed Shanthamma dead body lying on a cot in a pool of blood. On receipt of information he visited mango Orchard and noticed that some un-known persons had killed both Ushaiah and Shanthamma. Upon which a case has been registered and took up the investigation.

On the instructions of CP Rachakonda several teams were formed involving SOT, IT Cell, Clues Team etc., for the detection of the case.

While making efforts to detect the case on the specific information about the suspicious behaviour and attitude of the accused **Uppula Shiva Kumar**, he was taken into custody on 18-10-2024 at 1530 hrs at Nedunur X roads and questioned. On interrogation, he voluntarily confessed to have committed this offence and further stated that he had also committed the murder of one lady at Aruna Farm House Dasarlapally village in March 2023.

Further he lead the police to the scene of crime at Kothaguda village and shown the place of offence, explained the sequence of committing the crime and also shown the crime weapon i.e. Blood stained knife hidden in the neighbour's land and also shown the clothes wore at the time of offence and motor cycle b.no. TG TG07B2651 and his Mobile Phone were seized under cover of panchanama.

During the course of investigation the finger prints of the accused have been taken and sent to Finger Print Unit, Rachakonda for comparison. The Finger print expert analysed the finger prints and furnished his opinion that the finger prints of accused are matching with the chance prints collected in Cr No. 79/2023 U/s 302 IPC of PS Kandukur.

2.Cr.No. 79/2023 U/s 302 IPC of Kandukur PS

Facts of the case are that on 04.03.2023 at 00.20 hours, the complainant Sri. Pulivendula Chenchu Krishna Reddy, S/o Narendra Reddy, Age: 19 years, Occ: Student, R/o Aruna Farm House, Dasarlapally Village of Kandukur Mandal N/o Manavali Village, Ozili Mandal, Nellore District, AP State, lodged a complaint wherein he stated that, he along with his sister and parents are living at Aruna Farm house at Dasarlapally since November-2011, his father is working as supervisor whereas his mother Shailaja Reddy, Age about: 42 years used to help his father in the farm works, on 03-3-2023 at 19:50 hours his mother told him to bring curd and salt packet, on that, he went to Kadthal village. At that same time his father was at owner's guest house. When he was at Kadthal village around at 20:07 hours his father made a phone call and asked him the reason of barking the dog. He informed that, he was at Kadthal village. After 20 minutes when he returned to home he found his father crying. When he went into the kitchen room and he noticed his mother found dead in a pool of blood with axe cut injuries on her neck and back an also found the almaraiah opened . Some unknown persons killed her mother for no reason.

M.O of the Accused:

The accused addicted to alcohol and used to roam in the village without any reason/ work. He targets lone female workers especially lone female workers at form houses and attempts to get satisfy his sexual desire while he was under the influence of alcohol, when the victim resists he attack them with the available Knifes and sickles and kill them.

The Good work turned out by the Police personnel is highly appreciated and suitably rewarded.

The arrest of accused was made under the supervision and guidance of Sri G. Sudheer Babu, I.P.S., Commissioner of Police, Rachakonda.
