

PRESS NOTE

FAKE (BLACK) CURRENCY CHEATING RACKET BUSTED BY SOT, MALKAJGIRI & MALKAJGIRI POLICE, RACHAKONDA, APPREHENDED TWO "FOREIGNERS" AND SEIZED FAKE CURRENCY NOTES RS 25,00,000/- (Approx.) CHEMICAL SUBSTANCES AND CELL PHONES

On tip-off information the sleuths of SOT, Malkajgiri & Malkajgiri Police, Rachakonda apprehended two "foreigners" while they indulging in preparation of black currency denominations of 500 notes for cheating the innocent public, seized fake black currency Rs. 25,00,000/- (Approx) Chemical substances and three Mobile phones.

Cr.No. 62/2024, U/S 420 IPC, sec 3(ii) (e) of Foreigners Act of P.S Malkajgiri

The details of the accused persons:-

- 1: Kombi Frank Sedrick S/o Ngaii Clement, Age: 35yrs, R/o Sector -42 Gurgaon, Delhi N/o Cameroon Country. (Illegal staying, he is not having valid visa)
- 2: Goita Soungalo S/o Lassina Goita, Age: 52yrs , R/o Banaswadi Bangalore, N/o Mali country
- 3: Rolex (Not available for examination)
- 4: David (main organizer, Not available for examination)
- 5 : Joseph (Not available for examination)

Seized Property:-

1. Fake currency Rs.500 notes -Rs.25, 00,000/-(Approx),
2. Chemical substances,
3. Mobile Phones -03,
4. One Passport,
5. One small iron box.

Brief facts of the case:

In the month of November 2023, the complainant Vishnuvardhan Reddy, R/o Boduppall, Medipally, who is a Zomato delivery boy, received a notification through WhatsApp, i.e 'Verified Clone Credit Card' group in which he joined and started chatting. One David (Admin of the group) started chatting with him, in which he stated that he was having bundles of black currency notes which will turn into original currency when they dip into a chemical solution and offered rupees in 1:5 ratios to the complainant. On that the complainant agreed his offer. Then, David replied that their representative Rolex would come and give a demo.

On 29.12.2023, Rolex met the complainant in a car and gave demo at Mehdipatnam. Rolex brought some chemicals, black color notes with him and made a solution with those chemicals and dipped a Black color note in that liquid solution on that the black colored note turned into original currency of 500 rupee note which was given to the complainant for verification.

After verification the complainant agreed David's offer. On 5.1.2024 the complainant met Joseph and Kombi Frank Sedrick, representatives of David in a hotel at Madhapur, and gave Rs. 5,00,000/- to them for which they have given a bundle packed with polythene cover mentioning them as Rs: 25,00,000/- black currency notes (Fake currency) and some chemical substances.

Later, the complainant along with his friends Suresh and Janardhan came to his house and verified the black currency notes by cleaning with the chemical solution given by the offenders, but they did not turn into original currency. Then he came to know that he was cheated.

Kombi Frank Sedrick, Goita Soungalo David, Rolex and Joseph are formed into a group for cheating innocent people in the name of Black currency (Fake currency). They were sending whatsapp notifications to innocent people to join in 'Verify Clone Credit Card' whatsApp group and luring the innocent public by showing black colour coated currency.

In the late night of 23.01.2024 on receiving credible information, SOT, Malkajgiri team along with Malkajgiri police apprehended two Foreigners while they were at Anand Bagh, Malkajgiri and Seized Fake currency Rs. 500 notes, Rs. 25,00,000/- (Approx), Chemical Substances, Mobile Phones -03, One Passport & One small Iron Box. **On verification the visa of Kombi Frank Sedrick has expired in 2020 and he is illegally overstaying in India.**

The above arrests were made under the direct supervision of Sri. G. Sudheer Babu, IPS., Commissioner of Police, Rachakonda, and under the guidance of Sri. R. Giridhar, IPS., DCP, SOT-I, and police personal of SOT-I and Malakjgiri PS.
