### MAN HELD BY SOT MALKAJGIRI TEAM AND NEREDMET POLICE AND SEIZED (07) COUNTRY MADE WEAPONS ALONG WITH (11) LIVE ROUNDS FROM HIS POSSESSION

On 27.09.2024 on credible information, the sleuths of Special Operations Team, Malkajgiri Zone apprehended one person by name Bollinkala Sai Ram Reddy, s/o:Krishna Reddy, Age-25 yrs, Occ: Raymond shopping mall worker at Kakinada present, R/o: Sri Laxmi Deluxe Boys hostel, Opp Sri Sai Pooja Theatre Suraram, N/o: Near Jana Chaitanya Layout, Madhura nagar, Kakinada of AP State for illegal possession of fire arms and seized (07) Country made weapons 11 No's of live rounds from his possession.

Cr No 678/2024, U/s 25 (1) (A), 25 (1B) (a) of Arms Act of Neredmet Police Station.

### Details of the accused person:

 Bollinkala Sai Ram Reddy, s/o:Krishna Reddy, Age-25 yrs, Occ: Raymond shopping mall worker at Kakinada present, R/o: Sri Laxmi Deluxe Boys hostel, Opp Sri Sai Pooja Theatre Suraram, N/o: Near Jana Chaitanya Layout, Madhura nagar, Kakinada of AP State.

#### **Brief Facts:-**

Facts of the case are that, Bollinkala Sai Ram Reddy is the resident of Kakinada town of AP State, he discontinued B.com computers 4years back and he stayed at his home without any work for two years. Later worked in Raymond cloth shop at Kakinada as sales man. Later he shifted to Hyderabad and worked in Amazon at Nagole branch for 4 months as office boy and is having criminal back ground and involved (02) theft cases and went to jail. After release from jail he hatched plan to earn easy money and in this regard he contacted to one person n/o Maharashtra state for purchasing the weapons at a low price and selling at a high price in Hyderabad area for needy persons.

As per his plan the Sai Ram Reddy procured (07) different type weapons from one person of Maharasta State. Latter he hatched a plan to sell weapons and involve in criminal activities.

On 27-09-2024 at 2300hrs while the Sai Ram Reddy moving in RK puram area, on information SOT Malkajgiri Police along with Neredmet Police has arrested the accused and seized (07) Country made weapons (11) live rounds from his possession.
