

## **PRESS NOTE**

### **ARREST OF HABITUAL PROPERTY OFFENDER AND RECOVERY OF 23 MOTOR CYCLES, PRINTER, LAPTOP, FAKE REGISTRATION CARDS, EMPTY PRINTABLE INKJET CHIP CARDS, 6 BOTTLES OF COLOUR INK BY POLICE UPPAL**

As part of Rachakonda Commissionerate Mission, on 13.01.2024 in the early morning hours at 0330 hours, for implementation of Visible Policing Concept Sri. Koteshwara Rao, Detective Sub Inspector of Police, Uppal Police Station, Rachakonda along with his crime staff by complying the directives of the superior officers were conducting surprise vehicle checking at SVM Grand, Nagole Road. At that moment, they noticed an individual riding a motorcycle under suspicious circumstances as such, they halted his motor cycle and on enquiry with him, the unknown person disclosed his identity as Rayudu Chaithanya Sai Kumar, S/o Venkata Ramana, Age: 31 years, Caste: Balija, Occ: Private Employee, R/o: Sithaphalmandi, Mylargadda, Secunderabad, N/o: Manchukanti Nagar, Palvancha Town, Bhadradri – Kothagudem District. Despite of the initial hesitation, the details with regard to identity of Rayudu Chaithanya Sai Kumar were thoroughly verified in the readily accessible accused identifying police applications app and it was discovered that, Rayudu Chaithanya Sai Kumar is a habitual offender. Owing to it, Rayudu Chaithanya was brought to Uppal Police Station and on interrogation by Sri. Koteshwara Rao, Detective Sub Inspector of Police, Uppal PS, Rachakonda within the presence of two respectable mediators, he confessed that while he was perusing Polytechnic, he became addicted to bad vices and had desisted from his further education. Accordingly, for fulfilling his bad vices he by committing thefts of the two wheelers parked near Metro Stations is earning easy money by selling them to others by a way of changing their number plates.

Further, the accused confessed that he committed theft of two wheelers in the limits of following Police Stations and was involved in the below number of cases within each Police Station:

1. Uppal: 7 cases
2. Gopalapuram: 1 case
3. SR Nagar: 1 case
4. Begumpet: 02 cases
5. Khammam II Town: 02 cases

6. Kothagudem III Town: 01 case
7. Miyapur- 01 case
8. L.B nagar: 04 cases
9. Krishnalanka Vijayawada: 01 case
10. Other Police Stations: 03 cases

Items recovered from the possession of accused in respect of above said cases:

1. 23 Motorcycles
2. One Printer
3. One Laptop
4. Fake Registration Cards
5. Empty Printable Ink Jet Chip Cards
6. 6 bottles of colour ink

**Accused Details:**

- Rayudu Chaithanya Sai Kumar, S/o Venkata Ramana, Age: 31 years, Caste: Balija, Occ: Private Employee, R/o: Sithaphalmandi, Mylargadda, Secunderabad, N/o: Manchukanti Nagar, Palvancha Town, Bhadradi – Kothagudem District

Prior to this incident also, the accused was remanded to judicial custody for various times in respect of his involvement in identical type of cases within the premises of Choutuppal, Uppal, Madhapur Police Stations and others Police Stations. Despite of that also, accused after releasing from jail had failed to change his attitude and continued to commit theft of two wheelers for earning easy money. As of now, the arrest of accused was affected in FIR No. 42/2024, U/sec. 379 IPC of PS Uppal, Rachakonda and is being remanded to judicial custody.
