As per the directions of Sri G Sudheer Babu IPS, Commissioner of Police Rachakonda and on credible information, officer of CCS LB Nagar and Ibrahimpatnam Police Station apprehended following persons at Mangalpally X road on 2nd July 2025 at 8:30 AM in Cr.No. 317/2025 U/s 303 (3), 305 BNS of Ibrahimpatnam PS of Maheswaram Zone, Rachakonda Commissionerate.

Brief of accused A1 and A2:

Brief facts of the cases are, the accused A1: K. Sivananda, S/o Nagesh, age 52 years, Caste: Kurma, near Kurnool Bus Stand, Kurnool Town and A2: Shaik Ham Shareef S/o Jamal, age 38 Years, R/o Vallapally Village, Ballikuruva Mandal, Prakasham district, came to Hyderabad for eking livelihood by doing labour work and A1 staying in rented room since 6 months at NGO Colony Vanasthalipuram, whereas A2 is homeless and moving in LB labor addas. Both the accused got acquaintance with each other at labor addas, as both of them are drinkers and in need of money they planned to earn money wrongfully by committing thefts. Hence, A1 hatched a plan to commit idols theft in temples. As per their plan they need a vehicle to go to villages and for easy escape.

In order to proceed with their plan A1 and A2 started moving in villages of Yacharam and Ibrahimpatnam mandal for recee by hiring an auto. On 27th Feb 2025 they committed theft of 4 Temple Bells in Mallikarjuna Swamy Temple & Sivalayam at Gandlaguda of Yacharam mandal. And on15th June 2025, they went to Mallanna Swamy temple of Upparaguda village, Ibraheempatnam Mandal hiring Auto committed theft of Pustela thadu (100 mg weight) and 2 Deepam stands.

On 24-6-2025 they committed theft of Honda shine bike bearing No. AP28CE4724 which was parked near Metro Cash & Carry, Uppal (Cr.No.793/2025 u/s 303(2) BNS of Uppal PS). Since then they are moving in the villages of Ibraheempatnam and Abdullapurmet areas for recee. Accordingly on 29-6-2025 at about 11:04hrs they went to Saddupally village of Abdullapurmet and committed theft of Sri Rama, Sita and Laxmana panchaloha Idols from Hanuman temple. Later, on same day they went to Dandumailaram village of Ibraheempatnam and committed theft of (3) Ayyappa swamy panchaloha idols and one Ayyappa swamy silver Idol and other pooja items by breaking the lock. On the same day evening hours they went to one Sri Akkapally Kranthi Kumar, S/o Bala Yallaiah, age 31 years, Occ:Scrap Business, r/o 2-9-180/11/3, Bharathnagar,Uppal, Cell No.6301725241, Shiva Kumar Enterprises, Annapurna Colony, Mandi Market, Uppal n/o Dumpalapally vg, Dubbaka mandal of Siddipet dist for an amount of Rs.18,500/- and the amount spent for personal things.

Again on 30-06-2025 at about 1200 hrs,they visited Polkampally village of Ibrahimpatnam mandal on the same bike along with cloth bags to conceal the idols and committed theft in Shiva Ganga temples by break open the lock with short crowbars and committed theft of Peddaraju, Peddamma idols and immediately they went to Hanuman temple in the same village at about 12:57 hrs and break opened the lock and committed theft of 4 panchaloha idols of Sri Rama, Sita, Laxmana and Hanuma along with gold mangal sutra and then returned to their room.

Today i.e., 2nd July 2025 on credible information, CCS LB Nagar and Ibrahimpatnam police apprehended the offenders at Mangalpally X road at 8:30 AM and recovered the stolen property from the accused total worth Rs. 5,36,300/-(**Five lakhs thirty six thousand and three hundred rupees**) from A1, A2 and receiver.
