

## PRESS NOTE

### SOT MALKAJGIRI TEAM RACHAKONDA ALONG WITH CHAITANYAPURI L&O POLICE HAVE BURSTED INTERSTATE CHILD RACKET AND NABBED 11 PERSONS WHO WERE ILLEGALLY PROCURING AND SELLING INFANTS AND RESCUED (04) INFANTS (TWO BABY GIRLS AND TWO BABY BOYS) AND SEIZED 11 MOBILE PHONES, NET CASH RS 5,000/- ALL WORTH 95,000/-

On tip-off information the sleuths of SOT, Malkajgiri & Chaitanyapuri Police, Rachakonda have apprehended eleven persons who were illegally indulging in procuring and selling Infants to needy people among which one K. Krishnaveni & Deepthi have illegally procured Four Infants from one Vandana R/o: Ahmedabad, Gujarat State and the Infants were transported with the help of two others i.e, Sunitha suman and Savitri Devi and the Infants were sold to three needy families in AP and Telangana states through mediators Sharada and Sampath Kumar both R/o: Hyderabad.

#### **Brief History of Prime Accused:**

The accused Kola Krishnaveni is a resident of Quthbullapur of Medchal-Malkajgiri dist, she studied B.Sc Bio-chemistry, in the year 2016 while pursuing her graduation she got married to one Ravi kumar r/o Vikarabad. In the year 2019 she got divorced as she could not conceive. Later she joined abbot private limited company as a Medical representative in the year 2019. Later one of her known persons have approached her and requested her to cooperate in purchasing/adopting a child as she was in Medical field. Later on Kola Krishnaveni searched for adoption of Infants in social media and came into contact with one Manoj of Delhi in the year 2024. Manoj has assured of selling a Baby Boy for an amount of Rs 5 Lakhs, thereafter Manoj has brought the Baby Boy to Hyderabad and while they were about to sell the Boy Infant they were caught by Gopalapuram Police of Hyderabad City which is a subject matter of **Cr No.389/2024 U/s 80,81,87 Juvenile Justice Act of PS Gopalapuram PS of Hyderabad City.**

### **Modus Operandi:**

The Prime accused Kola Krishnaveni used to get offers of procuring Infants from her friend Battu Deepthi R/o: Kothapet and from Sampath Kumar R/o:Secunderabad who are well known to her since long time. The accused Kola Krishnaveni through Social media came into contact with Vandana R/o: Ahmedabad, Gujarat state and she has agreed to procure and send Infants to Hyderabad for an amount of Rs 1.5Lakhs for baby girl and 2.5 Lakhs for baby boy. Accordingly Vandana has sent 2 Baby Boys and 2 Baby Girls from Gujarat with the help of Sunitha suman and Savitri Devi, after securing the presence of Infants Kola Krishnaveni, Deepthi, Sampath Kumar through mediators Sharada, Umarani, Jayasree, Sravan, Soni keerthi, have sold Three Baby Infants to 3 different persons in AP and Telangana for an amount of Rs 2-3Lakhs per Baby Girl and 4-5 Lakhs per Baby Boy and shared the amount among themselves.

**Breakthrough of the case:** The SOT team Malkajgiri along with Chaitanyapuri Police, CWC members today on 25.02.2025 at 0600hrs on credible information rushed to Chaitanyapuri bus stop where they found Kola Krishnaveni, Savitri Devi, Sampath kumar along with an Infant Baby Boy under suspicious circumstances as such apprehended them and on interrogating them thoroughly they have confessed to have committed the crime of procuring Infants illegally and selling them to needy people, from there they have lead to the house of the accused Battu Deepthi where 3 more Infants were found who were secured in the same way. The accused further confessed that as they did not receive complete amount from the purchasers they have called all of them today on the pretext of giving birth certificates and adoption certificates. The following are the complete details of Infants sold.

1. **Baby Girl I:-** on 28.01.2025 the baby girl was procured from Vandana for an amount of Rs 2.3Lakhs, transported to Hyderabad by Sunitha suman and the Infant Girl was sold to Ogeti Sravani W/o Pavan Bhagavan Kumar R/o Vijayawada for an amount of Rs 2.7 Lakhs. The Profit of Rs 50,000/-was shared between Kola Krishnaveni and Deepthi.
2. **Baby Girl II:-** on 04.02.2025 the baby girl was procured from Vandana for an amount of Rs 2 Lakhs transported to Hyderabad by Sunitha suman and the Infant Girl was sold to Teppala swathi W/o Vinay kumar, R/o Saidabad, Hyderabad for an amount of Rs 2.5 Lakhs through mediator Amgoth Sharada. The Profit of Rs 50,000/- was shared between Kola Krishnaveni, Deepthi and Sharada.
3. **Baby Boy I:-** on 12.02.2025 the baby boy was procured from Vandana for an amount of Rs 4.2 Lakhs, transported to Hyderabad by Savitri Devi and the Infant Boy was sold to Lingala Ramesh S/o Late Venkateshwarlu R/o Mahaboobabad for Rs 4.8 Lakhs through mediator Amgoth Sharada. The Profit of Rs 50,000/- was shared between Kola Krishnaveni, Deepthi and Sharada.

4. **Baby Boy II:-** on 25.02.2025 the baby boy was procured from Vandana for an amount of Rs 4.2 Lakhs, transported to Hyderabad by Savitri Devi and Police on credible information apprehended them while she was handing over the Infant Boy to Krishnaveni and Sampath Kumar at Chaitanyapuri Bus stop.

**Appeal to Citizens:** It is hereby given appeal to all the citizens who want to adopt Infants/Children to follow due procedure of Law, do not approach any agents/ mediators who might procure Infants illegally and sell with out following due procedure.
