PRESS NOTE

IN CONTINUATION TO ARREST OF INTER-STATE GANG AND EARLIER RESCUE OF 4 INFANTS BY SOT-I OF RACHAKONDA ALONG WITH CHAITANYAPURI L&O POLICE HAVE TAKEN THE ACCUSED KOLA KRISHNAVENI, DEEPTHI AND VANDANA INTO POLICE CUSTODY AND DURING POLICE CUSTODY THEY CONFESSED THAT HAVE COMMITTED MORE NUMBER OF ILLEGAL PROCURATION AND SALES OF INFANTS ALONG WITH ONE AMULYA R/O: MALAKPET, HYDERABAD. A TOTAL OF 25 INFANTS WERE ILLEGALLY PROCURED AND SOLD (EARLIER 4 INFANTS WERE RESCUED) NOW 21 MORE INFANTS WERE IDENTIFIED AMONG WHICH 10 INFANTS WERE RESCUED AS OF NOW AND REMAINING 11 MORE INFANTS ARE YET TO BE RESCUED. IN THIS CONNECTION AMULYA WAS ALSO APPREHENDED AND SEIZED HER MOBILE PHONE

As per the confession of Kola Krishnaveni and Deepthi one more accused Amulya who was also involved in the illegal procuration and sales of Infants was identified. During Police custody Kola Krishnaveni has confessed the illegal procuration and sales of 3 more Infants (2 Boys & 1 Girl) among which one Girl was rescued. The second accused Deepthi confessed that she with Amulya has procured and sold 10 more Infants (4 Boys & 6 Girls) among which 4 Girls and 1 Boys were rescued. As per the confession one more prime accused Amulya was apprehended on **18.03.2025** and she has confessed to have illegally procured and sold 8 Infants (4 Boys & 4 Girls) among which 3 Girls and 1 Boys were rescued.

Brief History of the accused Amulya:

The accused Amulya is a resident of Malakpet of Hyderabad dist, she studied upto 10th standard, and after studies she started her career as Asha worker and at present working at UPHC, Azampura, Hyderabad. In the year 2011 she got married to Mallesh who is a driver by profession. During her marital life she was blessed with to Girl children. Later due to disputes her husband left and since then she has been residing alone with her two kids.

Modus Operandi:

Earlier Amulya used to serve as Asha worker as such she got into contact with one of the accused mediator Ismail who used to work as supervisor at Area Hospital, Malakpet, at that time Ismail has lured her of earning money easily and asked her to identify childless parents. As guided by Ismail Amulya has identified one of her relative by name Kotha Sugunamma R/o: Choutuppal who was childless as she could not conceive since her marriage. Later Ismail in the year 2022 has illegally procured an Infant Boy and sold the Boy to Kotha Sugunamma through Amulya and shared a profit of 30,000/- among them. Later Amulya came into contact with Kola Krishnaveni and Deepthi and since then she has been illegally procuring Infants on her own and along with Deepthi and used to sell the Infants to needy childless parents. Amulya through Deepthi and through social media secured the contacts of other state accused persons who were also illegally procuring and selling the Infants. A total of 8 Infants were procured and sold by Amulya on her own and with Deepthi she procured and sold 10 Infants.

Break through of the case: The SOT Malkajgiri team along with Chaitanyapuri Police, have technically analyzed and identified more procuration and sales of Infants during the custody of the accused Kola Krishnaveni and Deepthi, in addition to that one more accused Amulya was identified who was also illegally procuring and selling Infants. As per the confession of the accused Kola Krishnaveni 3 more Infants were identified, from Deepthi confession 10 more infants were identified. As per their confession 6 Infants were rescued and the accused Amulya was apprehended on 18.03.2025 and as per her confession 8 Infants were identified among which 4 Infants were rescued. A total of 11 more Infants are yet to be rescued. Special teams were formed and deployed for further rescue of Infants who were procured and sold illegally.

<u>Appeal to Citizens:</u> It is hereby given appeal to all the citizens who want to adopt Infants/Children to follow due procedure of Law, do not approach any Agents/Mediators who might procure the Infants illegally and sell without following due procedure.
