- The return to mainstream society of senior Maoist leader and Gaddar's contemporary, Mala Sanjeev, a DKSZC Secretariat Member (SCM), along with his wife Deena, a State Committee Member (SCM), after 45 years underground, is seen as a moral victory for the holistic and comprehensive strategy of Telangana Police towards the Maoist movement.
- Senior Maoist leader Mala Sanjeev (SCM) and his wife Perugula Parvathi (SCM), have returned to mainstream life after serving in the CPI (Maoist) for four decades.
- We urge all the underground Maoists native of Telangana also to return to their native villages.
- We reiterate our appeal: " పొరు ష్టు !! - ఊరు మళ్ళు !!".
- Each and every Maoist who gives up the CPI Maoist movement and joins the mainstream will be provided the benefits under the rehabilitation scheme announced by the Telangana Government.

Today, i.e., on 17.07.2025, two senior underground leaders of the banned CPI (Maoist) party joined the mainstream in the presence of the Commissioner of Police, Rachakonda. Motivated by the various welfare measures extended by the Telangana Government and Police Department, and the support shown towards those who have returned to the mainstream, they decided to lead a peaceful life with their families and surrendered before the Commissioner of Police, Rachakonda.

Details of the Maoist members joining the mainstream of public life:

1. Mala Sanjeev @ Ashok @ Lengu Dada, s/o Danayya, aged 62 years, n/o Yapral, Medchal–Malkajgiri District, Telangana State.

- **Rank:** State Committee Member (SCM) & Secretariat Member, Chaitanya Natya Manch (CNM), Dandakaranya Special Zonal Committee (DKSZC), Chhattisgarh.
- In 1980, he joined the Jana Natya Mandali (JNM) of CPI (ML) People's War under the leadership of Gummadi Vittal @ Gaddar and worked in it until 1986. As a key associate of Gaddar, he collaborated with members like Dappu Ramesh, Daya, Vidya, and Divakar in conducting various cultural programs across nearly 16 states in India to spread the ideology of CPI (ML) People's War and attract people to the movement.
- In 1982, he married Panjala Saroj @ Vidya, a native of Huzurabad area in Karimnagar district. In 2002, Vidya died in an exchange of fire (EOF) in the forest area of Ailapur in Kannaigudem mandal, Mulugu district, which falls under the Mahadevpur Area Committee.
- Subsequently, in 1996, he joined the armed wing of the CPI (ML) People's War group, specifically the Manuguru dalam, where he served as a Division Committee Member (DVCM). He later worked in the Eturunagaram, Pandava, and Mahadevpur dalams. In 2001, he was promoted as a State Committee Member (SCM) and worked under the North Telangana Special Zonal Committee (NTSZC).
- In 2003, he was transferred to the Dandakaranya Special Zonal Committee (DKSZC) and served as the in-charge of Chaitanya Natya Manch (CNM) under its jurisdiction.
- In 2007, he married Perugula Parvathi @ Bontala Parvathi @ Deena (ACM) as his second wife. Together, under the banner of CPI (Maoist)'s Chaitanya Natya Manch (CNM), they organized cultural programs across various regions of Dandakaranya to mobilize tribal communities towards the CPI (Maoist). Both of them composed and sang songs in Hindi, Telugu, and Koya languages, trained CNM cadres, and actively performed in programs aimed at attracting tribals to the Maoist ideology.
- In 2002, Mala Sanjeev managed to escape from an exchange of fire (EOF) that occurred in the forest of Ailapur in Kannaigudem mandal, Mulugu district.
- He also escaped from an exchange of fire (EOF) that took place in 2005 in the National Park area of Bijapur district, Chhattisgarh.

2. Perugula Parvathi @ Bontala Parvathy @ Deena, d/o Narayana, w/o Mala Sanjeev, age: 50 years, n/o Vankeshwaram Village, Padara Mandal, Nagarkurnool District, Telangana State. She is a State Committee Member (SCM) in DKSZC and a member of the Cultural Sub-Committee of Chaitanya Natya Manch, DKSZC.

- Perugula Parvathi @ Bontala Parvathi @ Deena joined the Upper Plateau dalam of the CPI (ML) People's War group in the Nallamala region in 1992. She later worked in the Panagal dalam and subsequently joined the Jana Natya Mandali (JNM). In 1998, she was promoted as an Area Committee Member (ACM) and continued her work within JNM.
- In 2004, she was transferred as an ACM to the Galikonda Area dalam under Visakhapatnam district of the AOBSZC, where she served until 2007. During the same year, she was transferred to the Dandakaranya Special Zonal Committee (DKSZC) in Chhattisgarh and joined the Chaitanya Natya Manch (CNM).
- In 2007, she married Mala Sanjeev @ Lengu Dada, and together they organized cultural programs under CNM. In 2016, she was promoted as a Division Committee Member (DVCM) and took charge as a member of the Cultural Sub-Committee of CNM under the DKSZC.
- In 2018, she was promoted as a State Committee Member (SCM) and continued working in the Chaitanya Natya Manch (CNM) under DKSZC until she left the party. She composed and sang songs in Hindi, Telugu, and Koya languages, trained CNM cadres, and actively worked to attract tribal communities in the Bastar region of Chhattisgarh towards the CPI Maoist ideology.
- In 2017, Deena escaped from an exchange of fire (EOF) that took place in the Maad Division.

- On behalf of the Telangana State Police Department, we appeal to senior underground Maoists to return to the mainstream. We urge Telangana Maoists to come back to their native villages and contribute to the development of Telangana.
